Iowa Code § 96.3(7) – Recovery of Benefit Overpayment

STATEMENT OF THE CASE:

The claimant filed an appeal from the January 20, 2021, (reference 03) unemployment insurance decision that concluded she was overpaid \$1,812.00 in unemployment insurance benefits. After proper notice, a telephone hearing was conducted on March 19, 2021. The hearing was held jointly with Appeal 21A-UI-03886-SN-T. The claimant participated. Official notice of the administrative records was taken.

ISSUES:

Has the claimant been overpaid any unemployment insurance benefits?

FINDINGS OF FACT:

The claimant filed a new claim for unemployment insurance benefits with an effective date of March 29, 2020.

The claimant filed for and received a total of \$1,812.00 in regular, state unemployment insurance benefits for the weeks between March 29, 2020 and June 20, 2020.

The unemployment insurance decision that disqualified the claimant from receiving unemployment insurance benefits has been reversed in a decision of the administrative law judge in appeal 21A-UI-03886-SN-T.

REASONING AND CONCLUSIONS OF LAW:

The issue in this case is whether the claimant was overpaid benefits.

Iowa Code section 96.3(7) provides, in pertinent part:

7. Recovery of overpayment of benefits.


a. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault,

the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

Since the decision disqualifying the claimant has been reversed, the claimant was not overpaid \$1,812.00 in unemployment insurance benefits.

DECISION:

The unemployment insurance decision dated January 20, 2021, (reference 03), is reversed. The claimant was entitled to the benefits she received.
