STATEMENT OF THE CASE:

On August 15, 2024, Team Staffing Solutions (employer) filed an appeal from the statement of charges dated August 9, 2024, reference 02, for the second quarter of 2024. A hearing was held on September 9, 2024, pursuant to due notice. McKenzie Sprague (claimant) did not participate. The employer participated through Manager, Charity Garrison. The Department's Exhibits D-1 through D-4 were admitted into the record. Administrative notice was taken of the claimant's unemployment administrative records including DBRO and WAGE-A.

ISSUES:

- I. Was the employer's protest timely?
- II. Was the employer's appeal from the statement of charges timely?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: The claimant separated from employment on February 13, 2023 and filed a claim for benefits effective December 17, 2023. The notice of claim was sent through the SIDES system on December 22, 2023. (Exhibit D-1). The employer received the notice of claim and submitted a protest through the SIDES system on December 22, 2023. (Exhibit D-2). A notice of fact-finding interview was not scheduled. The first notice the employer was being charged for the claimant's benefits was the receipt of the statement of charges mailed August 9, 2024 for the second quarter of 2024 that charged the employer \$75.36 for the claimant's benefits. (Exhibit D-3). The employer filed its appeal of that statement of charges on August 15, 2024. (Exhibit D-4).

The claimant's gross weekly benefit amount is \$154.00. (DBRO). The claimant earned more than \$1,540.00 since her separation from the employer and prior to filing for benefits.

REASONING AND CONCLUSIONS OF LAW:

For the reasons set forth below, the administrative law finds the employer time protested the notice of claim and has timely appealed the statement of charges. The administrative law judge further finds the claimant has requalified for benefits by earning ten times the weekly benefit amount in insured wages following the separation from this employer.

Iowa Code section 96.6(2) provides, in pertinent part:

2. Initial determination. A representative designated by the director shall promptly notify all interested parties to the claim of its filing, and the parties have ten days from the date of mailing the notice of the filing of the claim by ordinary mail to the last known address to protest payment of benefits to the claimant.

Iowa Code section 96.7(2)a(6) provides:

2. Contribution rates based on benefit experience.

a. (6) Within forty days after the close of each calendar quarter, the department shall notify each employer of the amount of benefits charged to the employer's account during that quarter. The notification shall show the name of each individual to whom benefits were paid, the individual's social security number, and the amount of benefits paid to the individual. An employer which has not been notified as provided in section 96.6, subsection 2, of the allowance of benefits to an individual, *may within thirty days after the date of mailing of the notification appeal to the department for a hearing to determine the eligibility of the individual to receive benefits.* The appeal shall be referred to an administrative law judge for hearing and the employer and the individual shall receive notice of the time and place of the hearing. [Emphasis added.]

Iowa Admin. Code r. 871-26.4 provides, in relevant part:

2. An appeal from an initial decision concerning the allowance or denial of benefits shall be filed, by mail, facsimile, or e-mail, online, or in person, not later than ten calendar days, as determined by the postmark or the date stamp after the decision was mailed to the party at its last-known address and shall state the following:

- a. The name, address and social security number of the claimant;
- b. A reference to the decision from which appeal is taken; and,
- c. The grounds upon which the appeal is based.

3. *Notwithstanding the provisions of subrule 26.4(2), a contributory employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 30 days from the mailing date of the quarterly statement of benefit charges.*


4. Also notwithstanding the provisions of subrule 26.4(2), a reimbursable employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 15 days of the mailing date of the quarterly billing of benefit charges.

The administrative law judge concludes that the employer timely protested the claim. Iowa Workforce Development did not issue a decision regarding whether claimant is eligible for benefits and whether this employer will be charged for the benefits. The employer's first notice they were being charged for claimant's benefits was the Statement of Charges for the second quarter of 2024 mailed August 9, 2024. The employer's appeal of the Statement of Charges is timely.

The claimant has requalified for benefits since the separation from this employer by earning ten times the weekly benefit amount in insured wages following the separation. See Iowa Code §§ 96.5(1)g and 96.5(2)a. Accordingly, benefits are allowed and the account of the employer shall not be charged.

DECISION:

The August 9, 2024, reference 02, statement of charges for the second quarter of 2024 is modified in favor of the appellant, which will appear as a credit of \$75.36 to the employer's account on a future statement of charges. The employer has filed a timely protest and appeal from that statement of charges. The claimant has requalified for benefits since the separation. Benefits are allowed, provided the claimant is otherwise eligible. The account of the employer (00303492) shall not be charged and a credit of \$75.36 shall be issued on a future statement of charges.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
