PL116-136, Sec. 2104(f)(2) – Overpayment of Federal Pandemic Unemployment Compensation

STATEMENT OF THE CASE:

The claimant Nathan L. Sanders appealed a representative's decision dated October 6, 2021 (reference 04), that concluded the claimant was overpaid Federal Pandemic Unemployment Compensation (FPUC) benefits. After a hearing notice was mailed to the claimant's last-known address of record, a telephone hearing was held on January 3, 2022, and was consolidated with the hearing for appeal 21A-UI-22463-S2-T. The claimant participated personally. The administrative law judge took official notice of the administrative record.

ISSUE:

The issue is whether the claimant is overpaid FPUC benefits.

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: On December 6, 2020, claimant filed a claim for regular unemployment insurance benefits. He received benefits for the two weeks ending December 19, 2020. Claimant then received PUA benefits for the one-week period ending April 17, 2021, due to an agency error. Claimant also received FPUC benefits in the amount of \$300.00 for the one-week period ending April 17, 2021, due to the agency error.

REASONING AND CONCLUSIONS OF LAW:

For the following reasons the administrative law judge concludes the claimant was overpaid FPUC benefits for the period in question.

PL116-136, Sec. 2104 provides, in pertinent part:

- (b) Provisions of Agreement
- (1) Federal pandemic unemployment compensation.--Any agreement under this section shall provide that the State agency of the State will make payments of regular compensation to individuals in amounts and to the extent that they would be determined if the State law of the State were applied, with respect to any

week for which the individual is (disregarding this section) otherwise entitled under the State law to receive regular compensation, as if such State law had been modified in a manner such that the amount of regular compensation (including dependents' allowances) payable for any week shall be equal to

- (A) the amount determined under the State law (before the application of this paragraph), plus
- (B) an additional amount of \$600 (in this section referred to as "Federal Pandemic Unemployment Compensation").

. . . .

- (f) Fraud and Overpayments
- (2) Repayment.--In the case of individuals who have received amounts of Federal Pandemic Unemployment Compensation to which they were not entitled, the State shall require such individuals to repay the amounts of such Federal Pandemic Unemployment Compensation to the State agency...

The decision of the representative dated October 6, 2021, (reference 04) is affirmed. Here, claimant received a PUA payment for a week in which he did not file a weekly claim, and which was paid out due to an agency error. As a result, claimant was overpaid FPUC benefits in the amount of \$300.00 to which he was not entitled, and those benefits must be recovered in accordance with the law.

DECISION:

The decision of the representative dated October 6, 2021, (reference 04) is affirmed. Claimant has been overpaid FPUC benefits in the amount of \$300.00, which must be repaid.
