# STATEMENT OF THE CASE:

Claimant filed an appeal from the August 1, 2023, (reference 01) unemployment insurance decision that allowed benefits effective July 30, 2023, based upon a determination that claimant initially failed to provide verification of his identity but subsequently did so. Claimant was notified of the hearing. A telephone hearing was held on August 28, 2023. The claimant participated personally along with Kathy Kruse. The administrative law judge took official notice of the administrative record including the fact-finding documents.

## **ISSUES:**

Is the claimant able to and available for work? Did the claimant timely provide verification of his identity? Did the claimant fail to report as directed by a department representative?

## FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Claimant, with the assistance of his wife, Kathy Kruse, filed a claim for unemployment insurance benefits effective July 2, 2023. Claimant was unable to verify his identity through the online verification process. Therefore, on the claim confirmation page, a notice appeared stating claimant was required to provide qualifying proof of identity to the agency by July 13, 2023, in order to prevent benefits from being delayed and the claim from being canceled. Neither claimant nor Ms. Kruse recalled seeing the message. The notification would have looked similar to the graphic below:

If we do not receive the required documents by Thursday, February 28, 2019, your benefits may be delayed and your claim may be cancelled. You will be able to file a weekly continued claim for benefits with an unverified identity.	

On July 7, 2023, the agency mailed a letter to claimant's address of record that stated if claimant was unable to provide proof of identity by July 13, 2023, "benefits may be delayed and ... claim may be canceled." Claimant received the letter. However, Ms. Kruse generally handled the mail and she was traveling for work when the letter was delivered. Claimant did not open the letter and read the notice.

In late-July 2023, Ms. Kruse returned home, read the letter from Iowa Workforce Development (IWD), and learned claimant's claim had been locked because claimant had not verified his identity. Claimant did not provide proof of identity until on or about July 31, 2023. The claimant's unemployment insurance claim was unlocked at that time. On August 1, 2023, IWD issued a decision finding claimant eligible for benefits effective July 30, 2023, as the requested identity verification documents had been provided.

## **REASONING AND CONCLUSIONS OF LAW:**

For the reasons that follow, the administrative law judge concludes claimant failed to provide timely verification of identity.

lowa Code section 96.4(3) provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work...

Iowa Admin. Code r. 871-24.3 provides:

A claim will not become valid until the identity of the claimant has been verified by the department.

(1) Upon the filing of a claim, notification shall be provided to the claimant if the claimant's identity was not verified.

(2) If the agency is unable to verify the claimant's identity in the claim application, the claimant must provide approved documents. Approved documents must include at least one document containing a social security number. The department shall determine the approved documents required to verify identity. The list of approved documents can be found at the nearest local workforce center or online.

(3) The claimant's identity will not be considered verified until approved documents have been provided. The claim shall remain locked from issuance of benefits until the claimant has provided the approved documents to verify identity.

(4) After filing a claim application, the claimant shall not be eligible for benefits for any week until approved documents are provided to verify identity.

(5) Approved documents must be provided or postmarked by Saturday at 11:59 p.m. of the week in which the approved documentation is due, and the claim shall be unlocked for all weeks following the most recent effective date of the claim application.

(6) If required documents are provided in any subsequent weeks following the due date, the claimant shall be eligible, provided there are no other outstanding issues with the claim, as of the Sunday of the week the claimant's identity was verified.

Iowa Admin. Code r. 871-24.23(11) provides:

Availability disqualifications. The following are reasons for a claimant being disqualified for being unavailable for work.

(11) Failure to report as directed to workforce development in response to the notice which was mailed to the claimant will result in the claimant being deemed not to meet the availability requirements.

In this case, IWD notified claimant that identity verification needed to be provided by July 13, 2023, in order to prevent benefits from being delayed or the claim being canceled. Claimant did not provide the requested documentation until July 31, 2023. There is no evidence in the record indicating claimant's failure to provide the required documentation in a timely manner was due to agency error. The administrative law judge finds claimant was not available for work until July 30, 2023, the week claimant's identity was verified.

Therefore, benefits are withheld from July 2, 2023, through July 29, 2023. Benefits are allowed effective July 30, 2023, provided claimant is otherwise eligible.

# **DECISION:**

The August 1, 2023, (reference 01) unemployment insurance decision is affirmed. Claimant was not available for work during the four-week period ending July 29, 2023, as he failed to provide verification of identity as required. Benefits are allowed effective July 30, 2023, provided claimant is otherwise eligible.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

1) The name, address, and social security number of the claimant.

2) A reference to the decision from which the appeal is taken.

3) That an appeal from such decision is being made and such appeal is signed.

4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final.
