STATEMENT OF THE CASE:

On August 31, 2022, Casey’s Marketing Company (employer) filed an appeal from the statement of charges dated August 9, 2022, reference 04, for the second quarter of 2022. A hearing was held at 10:00 a.m. on Monday, October 31, 2022, pursuant to due notice. Carol Mankowski (claimant) did participate. The employer did participate through Isabelle Kogut, Hearing Representative for Valeu NSN. The administrative law judge took official notice of the administrative record.

ISSUE:

Was the employer’s appeal from the statement of charges timely?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: The claimant filed a claim for benefits effective February 6, 2022, after another employer reduced her hours.

The employer received the unemployment insurance decision dated March 2, 2022 (reference 02) stating claimant was still employed and the employer was subject to charge. The employer appealed that decision dated March 17, 2022 through the third-party representative after the deadline to appeal had passed. The employer had a witness arranged to call in for the hearing scheduled for May 2, 2022, at 9:00 am., but that witness did not call in for the hearing. Therefore, a default decision was issued on May 13, 2022. See 22A-UI-07244-DZ-T. The employer did not receive this decision.

The first notice of the claimant’s claim for benefits was the receipt of the statement of charges mailed August 9, 202 for the second quarter of 2022 (reference 04). The employer filed its appeal of that statement of charges on August 31, 2022.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes the employer did file a timely appeal to the statement of charges.

Iowa Code section 96.6(2) provides, in pertinent part:

2. Initial determination. A representative designated by the director shall promptly notify all interested parties to the claim of its filing, and the parties have ten days from the date of mailing the notice of the filing of the claim by ordinary mail to the last known address to protest payment of benefits to the claimant.

Iowa Code section 96.7(2)a(6) provides:

2. Contribution rates based on benefit experience.

a. (6) Within forty days after the close of each calendar quarter, the department shall notify each employer of the amount of benefits charged to the employer's account during that quarter. The notification shall show the name of each individual to whom benefits were paid, the individual's social security number, and the amount of benefits paid to the individual. An employer which has not been notified as provided in section 96.6, subsection 2, of the allowance of benefits to an individual, *may within thirty days after the date of mailing of the notification appeal to the department for a hearing to determine the eligibility of the individual to receive benefits.* The appeal shall be referred to an administrative law judge for hearing and the employer and the individual shall receive notice of the time and place of the hearing. [Emphasis added.]

Iowa Admin. Code r. 871-26.4 provides, in relevant part:

2. An appeal from an initial decision concerning the allowance or denial of benefits shall be filed, by mail, facsimile, or e-mail, online, or in person, not later than ten calendar days, as determined by the postmark or the date stamp after the decision was mailed to the party at its last-known address and shall state the following:

- a. The name, address and social security number of the claimant;
- b. A reference to the decision from which appeal is taken; and,
- c. The grounds upon which the appeal is based.

3. Notwithstanding the provisions of subrule 26.4(2), a contributory employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 30 days from the mailing date of the quarterly statement of benefit charges.

4. Also notwithstanding the provisions of subrule 26.4(2), a reimbursable employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 15 days of the mailing date of the quarterly billing of benefit charges.

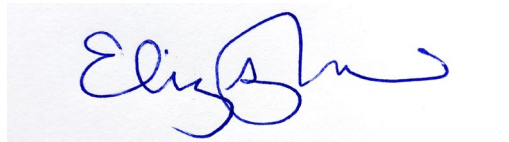
An employer is only allowed to appeal the statement of charges for a hearing to determine the eligibility of the individual to receive benefits if they were not previously notified pursuant to Iowa

Code section 96.6(2) of the allowance of benefits. Here, the employer has received – and responded to – multiple notices that the claimant was receiving benefits and their account was subject to charge for those benefits. Therefore, the employer cannot now prevail on a timely appeal of this statement of charges.

The administrative law judge will ensure a copy of 22AUI-07244-DZ-T is resent along with this decision so the employer receives it.

DECISION:

The August 9, 2022 (reference 04) statement of charges for the second quarter of 2022 is affirmed. The employer did not timely file an appeal from the first notification it had that the claimant was receiving benefits and it may be charged for those benefits.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at <https://www.legis.iowa.gov/docs/code/17A.19.pdf> or by contacting the District Court Clerk of Court <https://www.iowacourts.gov/iowa-courts/court-directory/>.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.

2.
