**STATEMENT OF THE CASE:**

The claimant Willie L. Coleman, Jr. appealed the March 23, 2022, (reference 05) decision that concluded the claimant was overpaid Federal Pandemic Emergency Unemployment Compensation (PEUC) benefits due to a disqualifying decision. A telephone hearing was held on May 10, 2022, and was consolidated with the hearing for appeals 22A-UI-07505-S2-T, 22A-UI-07507-S2-T, 22A-UI-07508-S2-T, 22A-UI-07510-S2-T, and 22A-UI-07511-S2-T. The claimant participated personally. Yalin Coleman testified on claimant's behalf. The administrative law judge took official notice of the administrative record.

**ISSUE:**

Is the claimant overpaid PEUC benefits?

**FINDINGS OF FACT:**

Having reviewed all of the evidence in the record, the administrative law judge finds: On April 28, 2021, Iowa Workforce Development (IWD) issued a decision (reference 03) that denied claimant regular state unemployment insurance (UI) benefits. That decision has been affirmed. See 22A-UI-07505-S2-T. Claimant has received PEUC benefits in the gross amount of \$6,601.00 for the twenty-three-week period ending March 6, 2021.

**REASONING AND CONCLUSIONS OF LAW:**

For the reasons that follow the administrative law judge concludes that the claimant has been overpaid PEUC benefits.

PL 116-136 Sec 2107 provides in pertinent part:

PANDEMIC EMERGENCY UNEMPLOYMENT COMPENSATION.

(2) PROVISIONS OF AGREEMENT. —

Any agreement under paragraph (1) shall provide that the State agency of the State will make payments of pandemic emergency unemployment compensation to individuals who—

(A) have exhausted all rights to regular compensation under the State law or under Federal law with respect to a benefit year (excluding any benefit year that ended before July 1, 2019);

(B) have no rights to regular compensation with respect to a week under such law or any other State unemployment compensation law or to compensation under any other Federal law;

(C) are not receiving compensation with respect to such week under the unemployment compensation law of Canada; and

(D) are able to work, available to work, and actively seeking work.

(e) FRAUD AND OVERPAYMENTS.—

...

(2) REPAYMENT.—In the case of individuals who have received amounts of pandemic emergency unemployment compensation under this section to which they were not entitled, the State shall require such individuals to repay the amounts of such pandemic emergency unemployment compensation to the State agency, except that the State agency may waive such repayment if it determines that—


(A) the payment of such pandemic emergency unemployment compensation was without fault on the part of any such individual; and

(B) such repayment would be contrary to equity and good conscience.

The decision that denied claimant regular unemployment insurance benefits remains in effect. Because claimant is not eligible for UI benefits, claimant is not eligible for PEUC benefits. Therefore, claimant has received PEUC benefits to which they were not entitled. The administrative law judge concludes that claimant has been overpaid PEUC benefits in the amount outlined in the findings of fact above. Those benefits must be recovered in accordance with Iowa law.

**DECISION:**

The March 23, 2022 (reference 05) decision is affirmed. Claimant has been overpaid PEUC benefits in the amount of \$6,601.00, which must be repaid.
