## STATEMENT OF THE CASE:

On April 14, 2022, Jhonathan Merida Barrios (claimant) filed a timely appeal from the April 5, 2022 (reference 03) decision that held the claimant was overpaid \$1,653.00 in benefits for 3 weeks between December 5, 2021 and December 25, 2021, due to an earlier decision that disqualified him for benefits based on a discharge from employment with PPG Excavating, L.L.C. After due notice was issued, a hearing was held on May 27, 2022. Claimant participated. The hearing in this matter was consolidated with the hearing in Appeal Number 22A-UI-09420-JT-T. Exhibit A, the online appeal, was received into evidence. The administrative law judge took official notice of the following Agency administrative records: the reference 01 and 03 decisions, KFFV and DBRO.

# ISSUE:

Whether the claimant was overpaid \$1,653.00 in benefits for 3 weeks between December 5, 2021 and December 25, 2021, due to an earlier decision that disqualified him for benefits based on a discharge from employment with PPG Excavating, L.L.C.

# FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds:

Jhonatan Merida Barrios (claimant) established an original claim for benefits that was effective December 5, 2021. Iowa Workforce Development set the weekly benefit amount at \$551.00. The claimant received \$1,653.00 in benefits for the three weeks between December 5, 2021 and December 25, 2021.

On February 15, 2022, lowa Workforce Development Benefits Bureau issued a reference 01 decision that disqualified the claimant for benefits, based on the deputy's conclusion that the claimant was discharged on December 5, 2021 from employment with PPG Excavating, L.L.C. for violation of a known company rule. The reference 01 decision prompted the overpayment decision from which the claimant appeals in the present matter. The reference 01 decision has been affirmed in Appeal Number 22A-UI-09420-JT-T.

## **REASONING AND CONCLUSIONS OF LAW:**

lowa Code section 96.3(7) provides, in pertinent part:

- 7. Recovery of overpayment of benefits.
- a. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

Because the reference 01 decision disqualified the claimant for benefits, and because the reference 01 decision remains in effect, the \$1,653.00 in benefits the claimant received for three weeks between December 5, 2021 and December 25, 2021 is an overpayment of benefits. The claimant must repay the overpaid benefits.

# **DECISION:**

The April 5, 2022 (reference 03) decision is AFFIRMED. The claimant was overpaid \$1,653.00 in benefits for 3 weeks between December 5, 2021 and December 25, 2021, due to the February 15, 2021 (reference 01) decision that disqualified the claimant for benefits in connection with a December 5, 2021 discharge from PPG Excavating, L.L.C. The claimant must repay the overpaid benefits.

- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final.
