STATEMENT OF THE CASE:

Maria C. Calderon Rodriguez, the claimant/appellant, filed an appeal from the Iowa Workforce Development (IWD) April 8, 2022, (reference 08) unemployment insurance (UI) decision. The decision concluded that Ms. Calderon Rodriguez was overpaid Federal Pandemic Unemployment Compensation (FPUC) benefits in the gross amount of \$1,800.00 for 6 weeks between May 2, 2021 and June 12, 2021. IWD concluded that Ms. Calderon Rodriguez was overpaid these benefits because IWD had previously concluded in its January 10, 2022 (reference 06) UI decision that Ms. Calderon Rodriguez was not eligible for REGULAR (state) UI benefits based on how her job ended with employer Carina Obrien; Charles Somers.

The lowa Department of Inspections and Appeals UI Appeals Bureau mailed notices of hearing to Ms. Calderon Rodriguez and IWD at each of their last known addresses of record for a telephone hearing scheduled for December 5, 2022. Ms. Calderon Rodriguez did not call the toll-free number listed on hearing notice at the time the hearing was scheduled to begin. IWD did not call the toll-free number listed on hearing notice at the time the hearing was scheduled to begin. Because Ms. Calderon Rodriguez filed the appeal but did not call in, no hearing was held.

ISSUE:

Should Ms. Calderon Rodriguez's appeal be dismissed based on her not appearing and participating?

FINDINGS OF FACT:

The parties were properly notified of the scheduled hearing for this appeal. Ms. Calderon Rodriguez did not call the toll-free number listed on the hearing notice at the time scheduled for this appeal hearing. She did not request a postponement of the hearing before the hearing

date. She did not call in before the record was closed, 15 minutes after the hearing was scheduled to begin. No hearing was held.

The hearing notice lists the hearing date of December 5, 2022, and the hearing time as 9:10 a.m. Iowa time. The hearing notice also advises parties:

IMPORTANT NOTICE!

YOU MUST CALL the toll-free number...at the time of the hearing. You may call up to 5 minutes before the hearing. You are not the organizer – Do **NOT** press 2.

The administrative law judge **WILL NOT** call you for the hearing, you **MUST** call into the number provided above to participate. Failure to participate in the hearing may result in the dismissal of your appeal. **Failure to participate in the hearing may result in dismissal of your appeal.**

The record was left open for a grace period of 15 minutes after the hearing start time to give Ms. Calderon Rodriguez a *reasonable* opportunity to participate. This reasonable amount of time is appropriate because if a hearing were conducted with the non-appealing party alone it would have likely concluded in 15 minutes or less. Allowing additional time would prejudice the non-appealing party for appearing in a timely manner. Holding Ms. Calderon Rodriguez in default for not appearing and participating during a 15-minute window after the hearing start time is reasonable considering the time allocated for each appeal hearing. Allowing this additional time period is more than reasonable under the circumstances.

The UI decision had concluded that Ms. Calderon Rodriguez was overpaid FPUC benefits in the gross amount of \$1,800.00 for 6 weeks between May 2, 2021 and June 12, 2021.

REASONING AND CONCLUSIONS OF LAW:

The Iowa Administrative Procedures Act at Iowa Code § 17A.12(3) provides in pertinent part:

If a party fails to appear or participate in a contested case proceeding after proper service of notice, the presiding officer may, if no adjournment is granted, enter a default decision or proceed with the hearing and make a decision in the absence of the party. ... If a decision is rendered against a party who failed to appear for the hearing and the presiding officer is timely requested by that party to vacate the decision for good cause, the time for initiating a further appeal is stayed pending a determination by the presiding officer to grant or deny the request. If adequate reasons are provided showing good cause for the party's failure to appear, the presiding officer shall vacate the decision and, after proper service of notice, conduct another evidentiary hearing. If adequate reasons are not provided showing good cause for the party's failure to appear, the presiding officer shall deny the motion to vacate.

Iowa Admin. Code r. 26.14(7) provides:

If a party has not responded to a notice of telephone hearing by providing the appeals bureau with the names and telephone numbers of the persons who are participating in the hearing by the scheduled starting time of the hearing or is not available at the telephone number provided, the presiding officer may proceed with the hearing. If the appealing party fails to provide a telephone number or is unavailable for the hearing, the presiding officer may decide the appealing party is in default and dismiss the appeal as provide in Iowa Code section 17A.12(3). The record may be reopened if the absent party makes a request in writing to reopen the hearing under subrule 26.8(3) and shows good cause for reopening the hearing.

a. If an absent party responds to the hearing notice while the hearing is in progress, the presiding officer shall pause to admit the party, summarize the hearing to that point, administer the oath, and resume the hearing.

b. If a party responds to the notice of hearing after the record has been closed and any party which has participated is no longer on the telephone line, the presiding officer shall not take the evidence of the late party.

c. Failure to read or follow the instructions on the notice of hearing shall not constitute good cause for reopening the record.

Due process requires notice and an opportunity to be heard, both of which were provided to the parties. The appellant is responsible for going forward with the case in a prompt and thoughtful manner. The appellant must be present at the start of the hearing to avoid a default judgment. lowa Code § 17A.12(3) and Iowa Admin. Code r. 26.14(7). The hearing notice instructs the parties to call the toll-free number listed on hearing notice at the time the hearing is scheduled to begin

The Iowa Supreme Court has held a default should not be set aside due to the appellant's negligence, carelessness, or inattention. See *Houlihan v. Emp't Appeal Bd.*, 545 N.W.2d 863 (Iowa 1996). Similarly, a default should not be set aside because the appellant has ignored clear requirements in the rules. Rather, a party must show it intended to proceed with the appeal and took steps to do so, but did not to appear because of some misunderstanding, accident, mistake or excusable neglect. Ms. Calderon Rodriguez was not present at the start of the hearing. As a *courtesy*, Ms. Calderon Rodriguez was granted additional time not required by statute or rule. The representative's decision remains in force and effect.

DECISION:

The April 8, 2022 (reference 08) UI decision finding Ms. Calderon Rodriguez was overpaid FPUC in the gross amount of \$1,800.00 remains in effect as Ms. Calderon Rodriguez is in default and the appeal is DISMISSED.

- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to <u>file a petition for judicial</u> <u>review in District Court</u> within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at <u>https://www.legis.iowa.gov/docs/code/17A.19.pdf</u> or by contacting the District Court Clerk of Court <u>https:///www.iowacourts.gov/iowa-courts/court-directory/</u>.

If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
