Iowa Code § 96.3(7) – Overpayment of Benefits

STATEMENT OF THE CASE:

The claimant filed an appeal from the August 8, 2023 (reference 06) unemployment insurance decision that found claimant was overpaid unemployment insurance benefits of \$593.00 for the one week ending July 1, 2023. The parties were properly notified of the hearing. A telephone hearing was held on August 28, 2023. The hearing was held with appeal numbers 23A-UI-07814-PT-T and 23A-UI-07815-PT-T and created one hearing record. The claimant participated personally. Iowa Workforce Development Integrity Bureau did not participate. The administrative law judge took official notice of the administrative record.

ISSUE:

Whether the claimant was overpaid benefits.

FINDINGS OF FACT:

Having heard the testimony and having examined the evidence in the record, the administrative law judge finds: Claimant's administrative records establish that she received unemployment insurance benefits of \$593.00 for the one week ending July 1, 2023. A decision dated July 21, 2023 (reference 04), was issued by Iowa Workforce Development (IWD) finding the claimant was not eligible for benefits for the week ending July 1, 2023, because claimant was not able to and available for work. A decision dated August 8, 2023 (reference 06), was issued by IWD and found that claimant was overpaid unemployment insurance benefits of \$593.00 for the one week ending July 1, 2023. Claimant appealed the reference 04 decision that disqualified her for the week ending July 1, 2023, and that decision was reversed in appeal number 23A-UI-07814-PT-T.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes:

Iowa Code section 96.3(7) provides:

7. Recovery of overpayment of benefits.


a. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

b. (1) (a) If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

The administrative law judge concludes that the claimant has not been overpaid unemployment insurance benefits funded by the State of Iowa in the amount of \$593.00 for the one week ending July 1, 2023, pursuant to Iowa Code § 96.3(7) as the disqualification decision that created the overpayment has been reversed in appeal number 23A-UI-07814-PT-T.

DECISION:

The August 8, 2023, (reference 06) unemployment insurance decision is reversed. The claimant was not overpaid \$593.00 in unemployment insurance benefits for the one week ending July 1, 2023, as the decision dated July 21, 2023 (reference 04), which initially created the overpayment, has been reversed in Appeal No. 23A-UI-07814-PT-T.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at <https://www.legis.iowa.gov/docs/code/17A.19.pdf> or by contacting the District Court Clerk of Court <https://www.iowacourts.gov/iowa-courts/court-directory/>.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.

- 4) Los fundamentos en que se funda dicho recurso.

Una decisión de la Junta de Apelaciones de Empleo es una acción final de la agencia. Si una de las partes no está de acuerdo con la decisión de la Junta de Apelación de Empleo, puede presentar una petición de revisión judicial en el tribunal de distrito.

2. Si nadie presenta una apelación de la decisión del juez ante la Junta de Apelaciones Laborales dentro de los quince (15) días, la decisión se convierte en acción final de la agencia y usted tiene la opción de presentar una petición de revisión judicial en el Tribunal de Distrito dentro de los treinta (30) días después de que la decisión adquiriera firmeza.
