Section 96.3-7 – Recovery of Overpayment of Benefits

STATEMENT OF THE CASE:

April M. Prugh (claimant) appealed a representative's April 25, 2006 decision (reference 08) that concluded she had been overpaid \$281.00 in benefits she received for the weeks ending March 4 through 25, 2006. The overpayment occurred as a result of a representative's April 24, 2006 decision that held the claimant was not eligible to receive benefits February 26 through April 29, 2006. After a hearing notice was mailed to the claimant's last-known address of record, a telephone hearing was held on May 11, 2006. The claimant participated in the hearing. Based on the evidence, the arguments of the claimant, and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law, and decision.

ISSUE:

Has the claimant been overpaid \$281.00 in unemployment insurance benefits?

FINDINGS OF FACT:

The claimant established a claim for unemployment insurance benefits during the week of August 14, 2005. The claimant filed claims for the weeks ending March 4 through 25, 2006. The claimant received a total of \$281.00 in benefits for these weeks.

The claimant appealed a representative's April 24, 2006 decision (reference 06) decision that concluded the claimant was not eligible to receive benefits from February 26 through April 29, 2006. This decision has been reversed. See decision for appeal 06A-UI-04540-DWT.

REASONING AND CONCLUSIONS OF LAW:

If an individual receives benefits she is not legally entitled to receive, the Department shall recover the benefits even if the individual acted in good faith and is not at fault in receiving the overpayment. Iowa Code §96.3-7. Based on the decision for appeal 06A-UI-04540-DWT, the claimant is legally entitled to receive benefits for the weeks ending March 4 through 25, 2006. The claimant has not been overpaid \$281.00 in benefits for these weeks.

DECISION:

The representative's April 25, 2006 decision (reference 08) is reversed. The claimant is legally entitled to receive benefits for the weeks ending March 4 through 25, 2006. The claimant has not been overpaid \$281.00 in benefits she received for these weeks.
