STATEMENT OF THE CASE:

The claimant filed an appeal from the October 13, 2022, (reference 01) unemployment insurance decision that concluded claimant was overpaid \$1,725.00 in regular unemployment insurance benefits due to failure to correctly report wages with Feuring Promotions Inc. After proper notice, a telephone hearing was conducted on November 14, 2022. The claimant, Diane Kucktra, participated. No exhibits were offered or admitted.

ISSUES:

Is claimant overpaid benefits? Is the claimant totally, partially or temporarily unemployed? Did the claimant correctly report wages earned? Is the claimant eligible for benefits based on the wages earned?

FINDINGS OF FACT:

Having reviewed all the evidence in the record, the administrative law judge finds:

Claimant began employment for this employer in September 2014 as a full-time embroidery. Technician. Claimant, Diane Kuckta, is no longer employed with this employer.

Claimant filed weekly continued claims for March 15, 2020 through October 3, 2020.

IWD conducted an audit of the claim, and contacted the employer to verify the claimant's wages earned with employer, Feuring Promotions Inc.

Because the Department concluded claimant did not accurately report her wages during this same period, an overpayment of \$1,725.00 was determined by IWD (See fact-finding documents). The claimant testified that she was paid \$17.50 per hour and worked 40 hours per week prior to the shut down in 2020. Claimant testified that the employer's information provided did not match the income she actually received. The claimant testified that the initial amount she provided to IWD was the accurate amount she received and that the amount provided by the employer was inaccurate.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes as follows:

Iowa Code section 96.3(3) provides:

3. Partial unemployment. An individual who is partially unemployed in any week as defined in section 96.1A, subsection 37, paragraph "b", and who meets the conditions of eligibility for benefits shall be paid with respect to that week an amount equal to the individual's weekly benefit amount less that part of wages payable to the individual with respect to that week in excess of one-fourth of the individual's weekly benefit amount. The benefits shall be rounded to the lower multiple of one dollar.

Iowa Code § 96.4(3) provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work. This subsection is waived if the individual is deemed partially unemployed, while employed at the individual's regular job, as defined in section 96.19, subsection 38, paragraph "b", subparagraph (1), or temporarily unemployed as defined in section 96.19, subsection 38, paragraph "c". The work search requirements of this subsection and the disqualification requirement for failure to apply for, or to accept suitable work of section 96.5, subsection 3, are waived if the individual is not disqualified for benefits under section 96.5, subsection 1, paragraph "h".

(emphasis added).

Iowa Code § 96.19(38)b provides:

As used in this chapter, unless the context clearly requires otherwise:

- 38. "Total and partial unemployment".
- a. An individual shall be deemed "totally unemployed" in any week with respect to which no wages are payable to the individual and during which the individual performs no services.
- b. An individual shall be deemed partially unemployed in any week in which either of the following apply:
- (1) While employed at the individual's then regular job, the individual works less than the regular full-time week and in which the individual earns less than the individual's weekly benefit amount plus fifteen dollars.
- (2) The individual, having been separated from the individual's regular job, earns at odd jobs less than the individual's weekly benefit amount plus fifteen dollars.
- c. An individual shall be deemed temporarily unemployed if for a period, verified by the department, not to exceed four consecutive weeks, the individual is unemployed due to a plant shutdown, vacation, inventory, lack of work, or emergency from the individual's regular job or trade in which the individual worked full-time and will again work full-time,

if the individual's employment, although temporarily suspended, has not been terminated.

Iowa Admin. Code r. 871-24.18 provides:

Wage-earnings limitation. An individual who is partially unemployed may earn weekly a sum equal to the individual's weekly benefit amount plus \$15 before being disqualified for excessive earnings. If such individual earns less than the individual's weekly benefit amount plus \$15, the formula for wage deductions shall be a sum equal to the individual's weekly benefit amount less that part of wages, payable to the individual with respect to that week and rounded to the lower multiple of one dollar, in excess of one-fourth of the individual's weekly benefit amount.

Iowa Admin. Code r. 871-23.3(1) provides:

(1) "Wages" means all remuneration for personal services, including commissions and bonuses and the cash value of all remuneration in any medium other than cash. Wages also means wages in lieu of notice, separation allowance, severance pay, or dismissal pay. The reasonable cash value of remuneration in any medium other than cash shall be estimated and determined in accordance with rule 23.2(96).

Iowa Code section 96.3(7) provides, in pertinent part:

- 7. Recovery of overpayment of benefits.
- a. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

The credible evidence in this case is that claimant received \$1,725.00 in regular unemployment insurance benefits based upon wages initially reported. The claimant testified at hearing that the wages she provided initially to IWD were correct and the amounts provided by the employer were incorrect. The claimant's information was not disputed at hearing.

As a result, the claimant was not overpaid benefits in the amount of \$1,725.00. The administrative law judge concludes therefore, that the overpayment was not correctly calculated.

DECISION:

The October 13, 2022 (reference 01) is reversed. The claimant was not overpaid \$1,725.00 in regular unemployment insurance benefits.

- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf or by contacting the District Court Clerk of Court https://www.iowacourts.gov/iowa-courts/court-directory/.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
