STATEMENT OF THE CASE:

On March 20, 2023, Brian Prusator (claimant/appellant) filed an appeal from the March 10, 2023, reference 01, unemployment insurance decision that denied benefits. A telephone hearing was held at on April 6, 2023 pursuant to due notice. The claimant, Brian Prusator, participated and testified. The employer Superior Cleaning Services, USA participated through Matthew Carroll, President. Claimant's exhibits A, B, C were admitted. The administrative law judge took official notice of the administrative record.

ISSUES:

Whether claimant's separation was a voluntary quit without good cause attributable to employer

FINDINGS OF FACT:

Having reviewed the evidence in the record, the administrative law judge finds: Claimant began working for employer on November 1, 2022. Claimant last worked as a full-time Vice President of Operations. Claimant was separated from employment on January 3, 2023, when he voluntarily quit his employment after a two-month trial period. Claimant testified that when he was hired he informed the employer that he would assess his suitability for the job duties at the end of the calendar year 2022 and determine if he would continue with the employer. At the end of December 2022, the claimant determined that he was not satisfied with numerous aspects of the position and quit his employment without notice. Claimant voluntarily quit his employment effective January 6, 2023.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes claimant's separation from the employment was without good cause attributable to the employer.

Iowa Code section 96.5(1) provides:

An individual shall be disqualified for benefits:

1. Voluntary quitting. If the individual has left work voluntarily without good cause attributable to the individual's employer, if so found by the department.

Iowa Admin. Code r. 871-24.25(12) provides:

Voluntary quit without good cause. In general, a voluntary quit means discontinuing the employment because the employee no longer desires to remain in the relationship of an employee with the employer from whom the employee has separated. The employer has the burden of proving that the claimant is disqualified for benefits pursuant to lowa Code section 96.5. However, the claimant has the initial burden to produce evidence that the claimant is not disqualified for benefits in cases involving lowa Code section 96.5, subsection (1), paragraphs "a" through "i," and subsection 10. The following reasons for a voluntary quit shall be presumed to be without good cause attributable to the employer:

(12) The claimant left without notice during a mutually agreed upon trial period of employment.

After a two-month trial period the claimant determined that he was not interested in continuing his employment based on a variety of factors. The claimant's decision to quit his employment was reasonable for him but was in no way attributable to his employer. Benefits are denied.

DECISION:

The March 10, 2023, (reference 01) unemployment insurance decision is affirmed. Claimant voluntarily left the employment without good cause attributable to the employer. Benefits are withheld until such time as he has worked in and been paid wages for insured work equal to ten times his weekly benefit amount, provided he is otherwise eligible.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may file a petition for judicial review in district court.

2. If you do not file an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at www.iowacourts.gov/efile. There may be a filing fee to file the petition in District Court.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
