Section 96.4-3 – Eligibility for Benefits

STATEMENT OF THE CASE:

Ruth A. Folsom filed an appeal from an unemployment insurance decision dated March 29, 2004 reference 07 which denied benefits to her for the period February 22-March 6, 2004. After due notice was issued, a telephone hearing was held April 19, 2004 with Ms. Folsom participating. This matter is considered on the consolidated record with 04A-UI-03523, 03524, 03525, 03528, 04036, and 04037-AT. The administrative law judge takes official notice of agency benefit payment records.

FINDINGS OF FACT:

Having heard the testimony of the witness and having examined all of the evidence in the record, the administrative law judge finds: During the two weeks between February 22, 2004 and March 6, 2004 Ruth A. Folsom was busy baby sitting and was not available for work.

REASONING AND CONCLUSIONS OF LAW:

The question is whether Ms. Folsom is eligible for unemployment insurance benefits for the two weeks ending March 6, 2004. She is not.

Iowa Code Section 96.4-3 provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work. This subsection is waived if the individual is deemed partially unemployed, while employed at the individual's regular job, as defined in section 96.19, subsection 38, paragraph "b", unnumbered paragraph 1, or temporarily unemployed as defined in section 96.19, subsection 38, paragraph "c". The work search requirements of this subsection and the disqualification requirement for failure to apply for, or to accept suitable work of section 96.5, subsection 3 are waived if the individual is not disqualified for benefits under section 96.5, subsection 1, paragraph "h".

The evidence establishes that Ms. Folsom was occupied with personal matters during the two weeks in question. Benefits must be withheld.

DECISION:

The unemployment insurance decision dated March 29, 2004 reference 07 is affirmed. The claimant is ineligible for unemployment insurance benefits for the two weeks ending March 6, 2004.
