Section 96.5-1 - Voluntary Quit

STATEMENT OF THE CASE:

Claimant filed an appeal from a decision of a representative dated July 14, 2004, reference 01, which held claimant ineligible for unemployment insurance benefits. After due notice, a telephone conference hearing was scheduled for and held on August 17, 2004. Claimant participated. Employer participated by Betty Kiel, Secretary.

FINDINGS OF FACT:

The administrative law judge, having heard the testimony and considered all of the evidence in the record, finds: Claimant last worked for employer on April 12, 2004. Claimant went off work on a voluntary leave of absence to farm. Claimant was contacted several times concerning the

return to work date with promises to return. Claimant did not return to work on the dates requested. Finally, claimant was deemed a voluntary quit for failure to return to work effective June 2, 2004.

REASONING AND CONCLUSIONS OF LAW:

The issue in this matter is whether claimant quit for good cause attributable to employer. The administrative law judge holds that the evidence has failed to establish that claimant voluntarily quit for good cause attributable to employer when claimant terminated the employment relationship by failing to come back to work in a reasonable time. Claimant never did go back to ask for his job. Claimant had greatly overextended the leave of absence. Even after that, the employer tried to get him to come back. Claimant never did go back to the workplace to ask for his job.

Iowa Code Section 96.5-1 provides:

An individual shall be disqualified for benefits:

1. Voluntary quitting. If the individual has left work voluntarily without good cause attributable to the individual's employer, if so found by the department.

DECISION:

The decision of the representative dated July 14, 2004, reference 01, is affirmed. Unemployment insurance benefits shall be withheld until claimant has worked in and been paid wages for insured work equal to ten times claimant's weekly benefit amount, provided claimant is otherwise eligible.
