Iowa Code § 96.3(7) – Recovery of Benefit Overpayment

STATEMENT OF THE CASE:

Alyssa J. Roach, the claimant/appellant,¹ appealed the Iowa Workforce Development March 20, 2025 (reference 06) unemployment insurance (UI) decision. IWD concluded that IWD overpaid Ms. Roach \$602.00 in REGULAR (state) UI benefits for the week of March 9-15, 2025 because a March 14, 2025 UI decision denied her UI benefits. Ms. Roach appealed on March 27, 2025. On March 31, 2025, the Iowa Department of Inspections, Appeals, and Licensing (DIAL), UI Appeals Bureau mailed a notice of hearing to Ms. Roach and IWD for a telephone hearing scheduled for April 18, 2025.

The administrative law judge held a telephone hearing on April 18, 2025. Ms. Roach participated in the hearing personally. IWD did not participate in the hearing. The administrative law judge took official notice of the administrative record from IWD, took official notice of the Administrative Law Judge Decisions in Appeals 25A-UI-02488-DZ-T and 25A-UI-02489-DZ-T, and admitted Department's Exhibits 1 and Claimant's Exhibit A as evidence.

The administrative law judge concludes IWD overpaid Ms. Roach \$602.00 in REGULAR (state) UI benefits for the week of March 9-15. 2025.

ISSUE:

Did IWD overpay Ms. Roach \$602.00 in REGULAR (state) UI benefits for the week of March 9, 2025 – March 15, 2025?

FINDINGS OF FACT:

Having reviewed the evidence in the record, the administrative law judge finds: Ms. Roach applied for REGULAR (state) UI benefits effective January 5, 2025. She reopened her UI claim effective January 19, 2025. IWD set her weekly UI benefit amount at \$602.00 before taxes, if any, are withheld.

¹ Claimant is the person who applied for UI benefits. Appellant is the person or employer who appealed.

In relevant part, Ms. Roach filed a weekly UI claim for the week of March 9-15, 2025. Ms. Roach reported earning \$0.00 in wages this week, and IWD paid her \$602.00 in UI benefits. After IWD had already sent her the money, IWD mailed Ms. Roach a UI decision on March 14, 2025 that denied her UI benefits as of March 9, 2025. Ms. Roach appealed this decision. The Administrative Law Judge Decision in Appeal 25A-UI-02488-DZ-T affirmed the March 14 UI decision.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes IWD overpaid Ms. Roach \$602.00 in REGULAR (state) UI benefits for the week of March 9-15, 2025.

Iowa Code §96.3(7) provides, in pertinent part:

7. Recovery of overpayment of benefits.

a. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

b. (1) (a) If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

IWD sent Ms. Roach \$602.00 in REGULAR (state) UI benefits for the week of March 9-15, 2025. After IWD already sent her the money, IWD found Ms. Roach not eligible for UI benefits as of March 9, 2025. When the Administrative Law Judge Decision in Appeal 25A-UI-02488-DZ-T affirmed the March 14 UI decision that meant Ms. Roach is still not eligible for UI benefits as of March 9, 2025.

Since Ms. Roach is not eligible for UI benefits as of March 9, 2025, IWD overpaid her \$602.00 in REGULAR (state) UI benefits for the week of March 9-15, 2025.

DECISION:

The March 20, 2025 (reference 06) UI decision is AFFIRMED. IWD overpaid Ms. Roach \$602.00 in REGULAR (state) UI benefits for the week of March 9-15, 2025. Ms. Roach is required to repay IWD for these benefits.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at lowa Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf or by contacting the District Court Clerk of Court https://www.iowacourts.gov/iowa-courts/court-directory/.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
