Section 96.3-7 - Recovery of Overpayment of Benefits

### STATEMENT OF THE CASE:

Anthony S. Steinbach (claimant) appealed a representative's April 21, 2004 decision (reference 03) that concluded he had been overpaid \$110.00 in benefits he received for the week ending April 10, 2004. The overpayment occurred as the result of a representative's April 20 decision that disqualified the claimant from receiving benefits as of April 4, 2004. After a hearing notice was mailed to the claimant's last-known address of record, a telephone hearing was held on May 10, 2004. The claimant participated in the hearing. Based on the evidence, the arguments of the claimant, and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law, and decision.

ISSUE:

Has the claimant been overpaid any benefits for the week ending April 10, 2004?

## FINDINGS OF FACT:

The claimant established a claim for benefits during the week of April 4, 2004. He filed a claim for the week ending April 10, 2004. He received \$110.00 in benefits for this week.

The claimant appealed the representative's April 20, 2004 decision that disqualified him from receiving unemployment insurance benefits as of April 4, 2004. This decision has been reversed. See decision for Appeal 04A-UI-04882-DWT.

## REASONING AND CONCLUSIONS OF LAW:

If an individual receives benefits he is not legally entitled to receive, the Department shall recover the benefits even if the individual acted in good faith and is not at fault in receiving the overpayment. Iowa Code §96.3-7. Based on the decision for Appeal 04A-UI-04882-DWT, the claimant is legally entitled to receive benefits for the week ending April 10, 2004. The claimant has not been overpaid \$110.00 in benefits he received for this week.

## DECISION:

The representative's April 21, 2004 decision (reference 03) is reversed. The claimant is legally entitled to receive unemployment insurance benefits during the week ending April 10, 2004. The claimant has not been overpaid \$110.00 in benefits he received for this week.
