Section 96.5-2-a – Discharge/Misconduct Section 96.3-7 – Recovery of Benefit Overpayment

STATEMENT OF THE CASE:

The employer filed a timely appeal from the May 26, 2005, reference 01, decision that allowed benefits. After due notice was issued, a hearing was held by telephone conference call before Administrative Law Judge Julie Elder on June 27, 2005. The claimant participated in the hearing. Dave Morin, Plant Manager, participated in the hearing on behalf of the employer. Employer's Exhibit One was admitted into evidence

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: The claimant was employed as a full-time closer for Aker Plastic Company from April 2, 2002 to

May 10, 2005. He was discharged for violating the employer's zero tolerance workplace violence policy. On May 9, 2005, the claimant threatened co-worker John Fults by stating he would break his legs, beat him to death and break his neck before putting his hands on Mr. Fults (Employer's Exhibit One). During the week of May 2, 2005, at least three employees reported altercations with the claimant including one incident where the claimant blocked another employee's car in with his car and then became very angry and threatened to "kick (his) ass" when the co-worker asked him to move his car (Employer's Exhibit One). On May 3, 2005, the claimant was upset with a female employee and "grabbed (her) butt again" (Employer's Exhibit One). She told him to stop and then reported it to the supervisor and stated she wanted to trade positions with another employee (Employer's Exhibit One). After break she returned to her previous position and the claimant "got in (her) face" and asked her why she was "making up stories" and continued to yell at her until she traded positions again (Employer's Exhibit One). The claimant received written warnings September 10, 2002, for using profanity and vulgarity toward a co-worker and January 15, 2004, for threatening and using profane language toward two co-workers.

The claimant has claimed and received unemployment insurance benefits after the separation from employment.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes the claimant was discharged from employment due to job-related misconduct.

Iowa Code section 96.5-2-a provides:

An individual shall be disqualified for benefits:

- 2. Discharge for misconduct. If the department finds that the individual has been discharged for misconduct in connection with the individual's employment:
- a. The individual shall be disqualified for benefits until the individual has worked in and has been paid wages for insured work equal to ten times the individual's weekly benefit amount, provided the individual is otherwise eligible.

871 IAC 24.32(1)a provides:

Discharge for misconduct.

- (1) Definition.
- a. "Misconduct" is defined as a deliberate act or omission by a worker which constitutes a material breach of the duties and obligations arising out of such worker's contract of employment. Misconduct as the term is used in the disqualification provision as being limited to conduct evincing such willful or wanton disregard of an employer's interest as is found in deliberate violation or disregard of standards of behavior which the employer has the right to expect of employees, or in carelessness or negligence of such degree of recurrence as to manifest equal culpability, wrongful intent or evil design, or to show an intentional and substantial disregard of the employer's interests or of the employee's duties and obligations to the employer. On the other hand mere inefficiency, unsatisfactory conduct, failure in good performance as the result of inability or

incapacity, inadvertencies or ordinary negligence in isolated instances, or good faith errors in judgment or discretion are not to be deemed misconduct within the meaning of the statute.

This definition has been accepted by the Iowa Supreme Court as accurately reflecting the intent of the legislature. <u>Huntoon v. Iowa Department of Job Service</u>, 275 N.W.2d 445, 448 (Iowa 1979).

The employer has the burden of proving disqualifying job misconduct. <u>Cosper v. IDJS</u>, 321 N.W.2d 6 (lowa 1982). The claimant had been warned about his behavior at work but despite those warnings he persisted in his inappropriate and unprofessional behavior toward co-workers. While it appears the employer was fortunate to avoid a more serious, physical situation between the claimant and several other employees as it did not respond to the problems in its workplace or aggressively protect its employees, the claimant's actions May 9, 2005, were not an isolated incident and his conduct demonstrated a willful disregard of the standards of behavior the employer has the right to expect of employees and shows an intentional and substantial disregard of the employer's interests and the employee's duties and obligations to the employer. Consequently, the administrative law judge concludes the employer has met its burden of proving disqualifying job misconduct. <u>Cosper v. IDJS</u>, 321 N.W.2d 6 (lowa 1982). Benefits are denied.

Iowa Code section 96.3-7 provides:

7. Recovery of overpayment of benefits. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

Because the claimant's separation was disqualifying, benefits were paid to which the claimant was not entitled. Those benefits must be recovered in accordance with the provisions of lowa law.

DECISION:

The May 26, 2005, reference 01, decision is reversed. The claimant was discharged from employment due to job-related misconduct. Benefits are withheld until such time as he has worked in and been paid wages for insured work equal to ten times his weekly benefit amount, provided hi is otherwise eligible. The claimant is overpaid benefits in the amount of \$1,288.00.
