Section 96.3-7 – Recovery of Overpayment of Benefits

STATEMENT OF THE CASE:

James C. DeLap (claimant) appealed a representative's June 6, 2006 decision (reference 03) that concluded he had been overpaid \$972.00 in benefits he received for the weeks ending January 21 through February 4, 2006. The overpayment occurred as the result of a representative's June 5 decision that disqualified the claimant from receiving benefits as of January 20, 2006. After a hearing notice was mailed to the claimant's last-known address of record, an in-person hearing was held on August 16, 2006, in Davenport, Iowa. The claimant participated in the hearing. Based on the evidence, the arguments of the claimant, and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law, and decision.

ISSUE:

Has the claimant been overpaid \$972.00 in unemployment insurance benefits?

FINDINGS OF FACT:

The claimant established a claim for unemployment insurance benefits during the week of January 1, 2006. The claimant filed claims for the weeks ending January 21 through February 4, 2006. He received a total of \$972.00 benefits for these weeks.

The claimant appealed a representative's June 5 decision that determined the claimant was not qualified to receive unemployment insurance benefits as of January 20, 2006, because he had quit his employment without good cause. This decision has been reversed. See decision for appeal 06A-UI-06124-DWT.

REASONING AND CONCLUSIONS OF LAW:

If an individual receives benefits he is not legally entitled to receive, the Department shall recover the benefits even if the individual acted in good faith and is not at fault in receiving the overpayment. Iowa Code § 96.3-7. Based on the decision for appeal 06A-UI-06124-DW, the claimant is legally entitled to receive benefits for the weeks ending January 21 through February 4, 2006. The claimant has not been overpaid \$972.00 in benefits he received for these weeks.

DECISION:

The representative's June 6, 2006 decision (reference 03) is reversed. The claimant is legally entitled to receive benefits for the weeks ending January 21 through February 4, 2006. The claimant has not been overpaid \$972.00 in benefits he received for these weeks.
