Section 96.4-3 – Eligibility for Benefits

STATEMENT OF THE CASE:

Robert C. Williams filed a timely appeal from an unemployment insurance decision dated April 28, 2004, reference 01, which denied benefits to him for the week ending April 3, 2004 upon a finding that he had indicated when filing his weekly claim for that week that he was not available for work. Due notice was issued for a telephone hearing to be held on May 21, 2004. The administrative law judge was unable to contact Mr. Williams at the number which he provided. This decision is based on information in his appeal letter.

FINDINGS OF FACT:

Having examined all matters of record, the administrative law judge finds: Robert C. Williams filed his weekly claim for unemployment insurance benefits for the week ending April 3, 2004 on a cell phone. He inadvertently indicated in response to a question on the voice response unit that he was not available for work. He was, in fact, available.

REASONING AND CONCLUSIONS OF LAW:

The question is whether the claimant is eligible for unemployment insurance benefits for the week ending April 3, 2004. He is.

Iowa Code Section 96.4-3 provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work. This subsection is waived if the individual is deemed partially unemployed, while employed at the individual's regular job, as defined in section 96.19, subsection 38, paragraph "b", unnumbered paragraph 1, or temporarily unemployed as defined in section 96.19, subsection 38, paragraph "c". The work search requirements of this subsection and the disqualification requirement for failure to apply for, or to accept suitable work of section 96.5, subsection 3 are waived if the individual is not disqualified for benefits under section 96.5, subsection 1, paragraph "h".

The evidence establishes that Mr. Williams inadvertently indicated that he was not available for work when he, in fact, was available. Benefits should be allowed. The claimant is reminded, however, of the Agency's caution against filing weekly claims by cell phone. Experience has shown the Agency that errors occur more easily when weekly claims are filed in that fashion.

DECISION:

The unemployment insurance decision dated April 28, 2004, reference 01, is reversed. The claimant is eligible for unemployment insurance benefits for the week ending April 3, 2004.
