## STATEMENT OF THE CASE:

The claimant, Ahlin Koffi, filed an appeal from the September 6, 2023 (reference 01), unemployment insurance, decision that denied benefits based upon his voluntary quit. The parties were properly notified about the hearing. A telephone hearing was held on September 26, 2023. Claimant, Ahlin Koffi, participated and testified. Employer, Fedex Ground Packages System Inc, did not participate in the hearing. No exhibits were offered or admitted.

## ISSUE:

Was the separation a layoff, discharge for misconduct or voluntary quit without good cause attributable to the employer?

## FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Claimant was hired in January 20, 2023. He worked as a full-time package handler. He quit in April 2023. The claimant resigned because he worked from 3:30 a.m. until 7:00 or 8:00 a.m. This work shift made it difficult for him to sleep. He also resigned because his job required him to lift heavy items and he felt it was too physical. The claimant never spoke with his employer about his concerns with his schedule and the physicality of the position.

## **REASONING AND CONCLUSIONS OF LAW:**

For the reasons that follow, the administrative law judge concludes claimant's separation from the employment was without good cause attributable to the employer.

Iowa Code §96.5(1) provides:

An individual shall be disqualified for benefits:

1. Voluntary quitting. If the individual has left work voluntarily without good cause attributable to the individual's employer, if so found by the department.

A voluntary leaving of employment requires an intention to terminate the employment relationship accompanied by an overt act of carrying out that intention. *Local Lodge #1426 v. Wilson Trailer*, 289 N.W.2d 608, 612 (lowa 1980). The claimant has the burden of proving that the voluntary leaving was for good cause attributable to the employer. lowa Code § 96.6(2) (amended 1998).

Iowa Code section 96.5(1) provides:

An individual shall be disqualified for benefits:

1. Voluntary quitting. If the individual has left work voluntarily without good cause attributable to the individual's employer, if so found by the department.

Iowa Admin. Code r. 871-24.25 provides:

Voluntary quit without good cause. In general, a voluntary quit means discontinuing the employment because the employee no longer desires to remain in the relationship of an employee with the employer from whom the employee has separated. The employer has the burden of proving that the claimant is disqualified for benefits pursuant to lowa Code section 96.5. However, the claimant has the initial burden to produce evidence that the claimant is not disqualified for benefits in cases involving lowa Code section 96.5, subsection (1), paragraphs "a" through "i," and subsection 10. The following reasons for a voluntary quit shall be presumed to be without good cause attributable to the employer:


(27) The claimant left rather than perform the assigned work as instructed.

Claimant has the burden of proving that the voluntary leaving was for good cause attributable to the employer. Iowa Code § 96.6(2). "Good cause" for leaving employment must be that which is reasonable to the average person, not the overly sensitive individual or the claimant in particular. *Uniweld Products v. Indus. Relations Comm'n*, 277 So.2d 827 (Fla. Dist. Ct. App. 1973). A voluntary leaving of employment requires an intention to terminate the employment relationship accompanied by an overt act of carrying out that intention. *Local Lodge #1426 v. Wilson Trailer*, 289 N.W.2d 608, 612 (Iowa 1980).

In this case, the claimant left work rather than working his shift. While the claimant perceived the job as being too physical, he did not discuss his concerns with his employer to seek other work options. A medical provider did not instruct the claimant to quit due to the physicality of the job. The claimant felt the shift of 3:00 a.m. to 7:00 or 8:00 a.m. affected his ability to sleep, however, the claimant did not discuss this concern with his employer to seek other work options. unit as too unsafe for him to take over as charge nurse, testimony was provided that a day shift While claimant had his own reasons for leaving, the reasons were not good cause attributable to the employer according to lowa law. Benefits are denied.

#### **DECISION:**

The September 6, 2023, (reference 01) unemployment insurance decision is affirmed. The claimant voluntarily left his employment without good cause attributable to the employer. Benefits are withheld until such time as he has worked in and been paid wages for insured work equal to ten times his weekly benefit amount, provided he is otherwise eligible.

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

#### AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. **Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
