**STATEMENT OF THE CASE:**

On March 28, 2023, claimant Gustavo A. Perez Juarez filed an appeal from the August 20, 2021 (reference 01) unemployment insurance decision that denied benefits based on a determination that his May 22, 2021 from employment was a voluntary quit without good cause attributable to the employer. The parties were properly notified of the hearing. A telephonic hearing was held at 10:00 a.m. on Thursday, April 13, 2023. Claimant Gustavo A. Perez Juarez participated personally. Employer Swift Pork Company participated through Tim Ash, HR Manager. Spanish/English interpreter Herman (ID number 15853) with CTS Language Link provided interpretation services for the hearing. The administrative law judge took official notice of the administrative record.

**ISSUE:**

Did the claimant file a timely appeal? Is there good cause to treat the claimant's appeal as timely?

**FINDINGS OF FACT:**

Having reviewed all of the evidence in the record, the administrative law judge finds: A decision finding claimant was not eligible for benefits based on his separation from Swift Pork Company was mailed to his last known address of record on August 20, 2021. Claimant did not remember receiving the decision. The first sentence of the decision states, "If this decision denies benefits and is not reversed on appeal, it may result in an overpayment which you will be required to repay." The decision contained a warning that an appeal must be postmarked or received by the Appeals Bureau by August 30, 2021. The appeal was not filed until March 28, 2023, which is after the date noticed on the disqualification decision.

Claimant moved in September 2021 from the Plum Street address to the Davis Street address. He did not set up mail forwarding so that his mail would be sent to his new address because his mother remained living at the Plum Street residence. However, claimant did not regularly visit the residence or ask for his mail, so he did not receive documents in a timely manner. Additionally, he does not keep the documents that Iowa Workforce Development sends him.

## REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes claimant failed to file a timely appeal and did not present any good-cause reason that would justify filing a late appeal and treating the appeal as timely. Benefits are denied.

Iowa Code § 96.6(2) provides, in pertinent part: “[u]nless the claimant or other interested party, after notification or within ten calendar days after notification was mailed to the claimant's last known address, files an appeal from the decision, the decision is final and benefits shall be paid or denied in accordance with the decision.”

Iowa Admin. Code r. 871-24.35(1) provides:

1. Except as otherwise provided by statute or by division rule, any payment, appeal, application, request, notice, objection, petition, report or other information or document submitted to the division shall be considered received by and filed with the division:

(a) If transmitted via the United States Postal Service on the date it is mailed as shown by the postmark, or in the absence of a postmark the postage meter mark of the envelope in which it is received; or if not postmarked or postage meter marked or if the mark is illegible, on the date entered on the document as the date of completion.

(b) If transmitted via the State Identification Data Exchange System (SIDES), maintained by the United States Department of Labor, on the date it was submitted to SIDES.

(c) If transmitted by any means other than [United States Postal Service or the State Identification Data Exchange System (SIDES)], on the date it is received by the division.

Iowa Admin. Code r. 871-24.35(2) provides:

2. The submission of any payment, appeal, application, request, notice, objection, petition, report or other information or document not within the specified statutory or regulatory period shall be considered timely if it is established to the satisfaction of the division that the delay in submission was due to division error or misinformation or to delay or other action of the United States postal service.


The Iowa Supreme Court has declared that there is a mandatory duty to file appeals from representatives' decisions within the time allotted by statute, and that the administrative law judge has no authority to change the decision of a representative if a timely appeal is not filed. *Franklin v. IDJS*, 277 N.W.2d 877, 881 (Iowa 1979). Compliance with appeal notice provisions is jurisdictional unless the facts of a case show that the notice was invalid. *Beardslee v. IDJS*, 276 N.W.2d 373, 377 (Iowa 1979); see also *In re Appeal of Elliott* 319 N.W.2d 244, 247 (Iowa 1982).

Claimant admits he did not retain documents sent to him by Iowa Workforce Development. He is relying solely on his memory from almost two years ago, and he does not remember whether he received the decision at issue. The administrative law judge finds that claimant received the decision in the mail and, therefore, had an opportunity to file an appeal prior to the appeal deadline. Claimant did not present any information indicating he was having problems receiving mail before he moved or any other testimony that indicated he did not receive the decision.

Claimant's delay in appealing was not due to an error or misinformation from the Department or due to delay or other action of the United States Postal Service. No other good cause reason has been established for the delay. Claimant's appeal was not filed on time and the administrative law judge lacks legal authority to decide the other issue in this matter.

**DECISION:**

The August 20, 2021 (reference 01) unemployment insurance decision is affirmed. Claimant failed to file a timely appeal. The decision of the representative remains in effect.

**APPEAL RIGHTS.** If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

**AN APPEAL TO THE BOARD SHALL STATE CLEARLY:**

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at <https://www.legis.iowa.gov/docs/code/17A.19.pdf> or by contacting the District Court Clerk of Court <https://www.iowacourts.gov/iowa-courts/court-directory/>.

**Note to Parties:** YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

**Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
