Section 96.5-2-a - Discharge

STATEMENT OF THE CASE:

The employer, Metz Baking, filed an appeal from a decision dated August 20, 2004, reference 03. The decision allowed benefits to the claimant, Roger Murtha. After due notice was issued a hearing was held by telephone conference call on September 16, 2004. The claimant participated on his own behalf and was represented by Dennis McElwain. The employer participated by Human Resources Administrator Jill Gill.

FINDINGS OF FACT:

Having heard the testimony of the witnesses and having examined all of the evidence in the record, the administrative law judge finds: Roger Murtha was employed by Metz Baking from June 29, 1978 until July 15, 2004. He was a full-time janitor.

The claimant was injured in a work-related accident and as of June 30, 2004, was released by this doctor with permanent restrictions. These restrictions rendered him unable to do the essential functions of his job and he was released from his employment by Human Resources Manager Paula Peterson.

REASONING AND CONCLUSIONS OF LAW:

The issue is whether the claimant is disqualified. The judge concludes he is not.

Iowa Code Section 96.5-2-a provides:

An individual shall be disqualified for benefits:

2. Discharge for misconduct. If the department finds that the individual has been discharged for misconduct in connection with the individual's employment:

a. The individual shall be disqualified for benefits until the individual has worked in and has been paid wages for insured work equal to ten times the individual's weekly benefit amount, provided the individual is otherwise eligible.

871 IAC 24.32(1)a provides:

Discharge for misconduct.

(1) Definition.

a. "Misconduct" is defined as a deliberate act or omission by a worker which constitutes a material breach of the duties and obligations arising out of such worker's contract of employment. Misconduct as the term is used in the disqualification provision as being limited to conduct evincing such willful or wanton disregard of an employer's interest as is found in deliberate violation or disregard of standards of behavior which the employer has the right to expect of employees, or in carelessness or negligence of such degree of recurrence as to manifest equal culpability, wrongful intent or evil design, or to show an intentional and substantial disregard of the employer's interests or of the employee's duties and obligations to the employer. On the other hand mere inefficiency, unsatisfactory conduct, failure in good performance as the result of inability or incapacity, inadvertencies or ordinary negligence in isolated instances, or good faith errors in judgment or discretion are not to be deemed misconduct within the meaning of the statute.

This definition has been accepted by the Iowa Supreme Court as accurately reflecting the intent of the legislature. <u>Huntoon v. Iowa Department of Job Service</u>, 275 N.W.2d 445, 448 (Iowa 1979).

The claimant was discharged because he was no longer able to perform the essential functions of his job due to physical incapacity. This is not misconduct and disqualification may not be imposed.

DECISION:

The representative's decision of August 20, 2004, reference 03, is affirmed. Roger Murtha is qualified for benefits, provided he is otherwise eligible.
