Section 96.3-7 – Recovery of Overpayment of Benefits

STATEMENT OF THE CASE:

Ntekolo D. Mambulu (claimant) appealed a representative's October 28, 2004 decision (reference 02) that concluded he had been overpaid \$398.00 in benefits he received for the weeks ending October 2 and 9, 2004. The overpayment occurred as the result of a representative's October 26, 2004 decision that disqualified the claimant from receiving benefits as of September 26, 2004. After a hearing notice was mailed to the claimant's last-known address of record, a telephone hearing was held on November 23, 2004. The claimant participated in the hearing. Based on the evidence, the arguments of the claimant, and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law, and decision.

ISSUE:

Has the claimant been overpaid any unemployment insurance benefits he received for the weeks ending October 2 and 9, 2004?

FINDINGS OF FACT:

The claimant established a claim for unemployment insurance benefits during the week of September 26, 2004. The claimant filed claims for the weeks ending October 2 and 9, 2004. He received a total of \$398.00 in benefits for these weeks.

The claimant appealed a representative's October 26, 2004 decision that disqualified him from receiving benefits as of September 26, 2004. This decision has been modified, but the modification has no legal consequence. See decision for appeal 04A-UI-11661-DWT.

REASONING AND CONCLUSIONS OF LAW:

If an individual receives benefits he is not legally entitled to receive, the Department shall recover the benefits even if the individual acted in good faith and is not at fault in receiving the overpayment. Iowa Code §96.3-7. Based on the decision for appeal 04A-UI-11661-DWT, the claimant is not legally entitled to receive benefits of the weeks ending October 2 and 9. The claimant has been overpaid \$398.00 in benefits he received for these weeks.

DECISION:

The representative's October 28, 2004 decision (reference 02) is affirmed. The claimant is not legally entitled to receive benefits for the weeks ending October 2 and 9, 2004. The claimant has been overpaid and must repay \$398.00 in benefits he received for these weeks.
