Section 96.4-3 - Able to and Available for Work Section 96.19-38-b - Eligibility for Partial Unemployment Insurance Benefits

STATEMENT OF THE CASE:

The employer appealed an unemployment insurance decision dated June 28, 2005, reference 01, that concluded the claimant was eligible to receive partial unemployment insurance benefits and the employer's account was chargeable for benefits paid to the claimant since her hours and/or wages had been reduced. A telephone hearing was held on July 26, 2005. The parties were properly notified about the hearing. The claimant participated in the hearing. Jason Povlick participated in the hearing on behalf of the employer.

FINDINGS OF FACT:

The claimant worked for the employer as a cashier 25 to 35 hours per week starting April 11, 1994. In 2005, her rate of pay was \$12.69 per hour. In April 2005 the claimant was on leave under the family and medical leave act. While she was on leave, the district manager informed

her that because the average number of hours that she worked was below 20 hours, she would be considered a casual worker, which meant that she would no longer receive employee benefits such as insurance and vacation leave.

When the claimant came back to work at the end of April 2005, her hours were substantially reduced due to a slowdown in the employer's business. The table below shows the hours she was scheduled and worked and her earnings for the weeks following her application for unemployment insurance benefits:

As a result of the reduction in hours, the claimant filed a new claim for unemployment insurance benefits with an effective date of May 29, 2005. Her weekly benefit amount was determined to be \$155.00 based on her wages during the year 2004.

REASONING AND CONCLUSIONS OF LAW:

The issue in this case is whether the claimant was eligible for partial unemployment insurance benefits effective May 29, 2005. The claimant filed a claim requesting partial unemployment insurance benefits for the weeks in which her earnings were less than the weekly benefit amount.

Iowa Code Section 96.3-3 provides:

3. Partial unemployment. An individual who is partially unemployed in any week as defined in section 96.19, subsection 38, paragraph "b", and who meets the conditions of eligibility for benefits shall be paid with respect to that week an amount equal to the individual's weekly benefit amount less that part of wages payable to the individual with respect to that week in excess of one-fourth of the individual's weekly benefit amount. The benefits shall be rounded to the lower multiple of one dollar.

Iowa Code Section 96.19-38-b provides in part:

b. An individual shall be deemed partially unemployed in any week in which, while employed at the individual's then regular job, the individual works less than the regular full-time week and in which the individual earns less than the individual's weekly benefit amount plus fifteen dollars.

The preponderance of the evidence establishes the claimant's regular workweek at the point she filed her new claim was 20 to 25 hours per week. She was working less than that regular workweek due to a reduction in hours effective May 29, 2005, and she was entitled to partial

unemployment insurance benefits since her earnings were less than her weekly benefit amount plus \$15.00.

The unemployment insurance law provides that an individual be able to and available for work. Iowa Code Section 96.4-3. The claimant was able to and available to work and did not restrict the number of hours she was willing to work after she applied for unemployment insurance benefits.

The final issue is whether the employer's account is subject to charge for benefits paid to the claimant.

Iowa Code Section 96.7-2-a(2) provides in part:

(2) The amount of regular benefits . . . paid to an eligible individual shall be charged against the account of the employers in the base period in the inverse chronological order in which the employment of the individual occurred.

However, if the individual to whom the benefits are paid is in the employ of a base period employer at the time the individual is receiving the benefits, and the individual is receiving the same employment from the employer that the individual received during the individual's base period, benefits paid to the individual shall not be charged against the account of the employer.

The employer's account is subject to charge for benefits because the employer did not provide the claimant with the same employment as provided during the base period.

DECISION:

The unemployment insurance decision dated June 28, 2005, reference 01, is affirmed. The claimant is qualified to receive unemployment insurance benefits, if she is otherwise eligible. The employer's account will be subject to charge for benefits paid to the claimant.
