# STATEMENT OF THE CASE:

Rabiner Treatment Center (employer) appealed a representative's January 3, 2005 decision (reference 01) that concluded Nicole R. Dickerson (claimant) was qualified to receive unemployment insurance benefits, and the employer's account could be charged for benefits because the claimant had been discharged for nondisqualifying reasons. A hearing was scheduled for January 21, 2005. Prior to the hearing, the employer made a request to withdraw its appeal. Based on the employer's withdrawal request, the administrative record, and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law, and decision. being held, the appellant requested the appeal be withdrawn.

FINDINGS OF FACT:

Joyce Zehr, the employer's human resource manager, sent the Appeals Section a letter on January 7, 2005. This letter indicated the employer was withdrawing its appeal.

REASONING AND CONCLUSIONS OF LAW:

871 IAC 26.8(1) provides:

(1) An appeal may be withdrawn at any time prior to the issuance of a decision upon the request of the appellant and with the approval of the presiding officer to whom the case is assigned. Requests for withdrawal may be made in writing or orally, provided the oral request is tape-recorded by the presiding officer.

The employer's request to withdraw its appeal is approved.

DECISION:

The representative's January 3, 2005 decision (reference 01) is affirmed. The employer's request to withdraw its appeal is approved. This means the claimant remains qualified to receive unemployment insurance benefits as of December 5, 2004, provided she meets all other eligibility requirements.
