871IAC26.8(1) - Withdrawal of Appeal

STATEMENT OF THE CASE:

Iowa Department of Human Services – Cherokee (employer) appealed a representative's March 23, 2004 decision (reference 01) that concluded Adam J. Benson (claimant) was qualified to receive benefits, and the employer's account was subject to charge because the claimant had been discharged for nondisqualifying reasons. A hearing was scheduled for April 22, 2004. Prior to the hearing being held, the employer's representative made a request to withdraw the employer's appeal. Based on the employer's withdrawal request, the administrative record, and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law, and decision.

FINDINGS OF FACT:

The employer's representative, TALX UC Express, faxed a withdrawal request in this matter on April 9, 2004.

REASONING AND CONCLUSIONS OF LAW:

871 IAC 26.8(1) provides:

(1) An appeal may be withdrawn at any time prior to the issuance of a decision upon the request of the appellant and with the approval of the presiding officer to whom the case is assigned. Requests for withdrawal may be made in writing or orally, provided the oral request is tape-recorded by the presiding officer.

The employer's request to withdraw its appeal is approved.

DECISION:

The representative's March 23, 2004 decision (reference 01) is affirmed. The employer's request to withdraw its appeal is approved. The claimant is qualified to receive unemployment insurance benefits as of February 29, 2004, provided he meets all other eligibility requirements. During the claimant's current benefit year, the employer's account will not be charged because the employer is not a base period employer.
