#### STATEMENT OF THE CASE:

The claimant filed an appeal from the January 26, 2023, (reference 03) unemployment insurance decision that concluded she was overpaid \$531.00 in unemployment insurance benefits. After proper notice, a telephone hearing was scheduled to be conducted on November 15, 2023. The administrative law judge granted the claimant's request for postponement.

A new hearing was scheduled to occur on November 29, 2023, at 11:00 a.m. The administrative law judge reopened the record for 23A-UI-10226-SN-T. The hearing was held jointly with appeal 23A-UI-10225-SN-T and 23A-UI-10226-SN-T. The claimant participated. Exhibit D1 and D2 were received into the record.

# **ISSUES:**

Whether the claimant's appeal is timely? Whether there were circumstances beyond the claimant's control that warrant extension of the appeal period to preserve due process?

Has the claimant been overpaid any unemployment insurance benefits?

### FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds:

An overpayment decision was mailed to claimant's last known address of record on January 26, 2023. She received the decision within ten days. The decision contained a warning that an appeal must be postmarked or received by the Appeals Bureau by February 5, 2023. (Exhibit D1) The appeal was not filed until October 29, 2023, which is after the date noticed on the disqualification decision. (Exhibit D2).

The claimant excused the delay on circumstances with taking care of her mother's chronic health needs.

### REASONING AND CONCLUSIONS OF LAW:

The administrative law judge concludes the claimant's appeal is untimely. There were not circumstances beyond her control that warrant extension of the appeal period to preserve due process.

lowa Code § 96.6(2) provides, in pertinent part: "[u]nless the claimant or other interested party, after notification or within ten calendar days after notification was mailed to the claimant's last known address, files an appeal from the decision, the decision is final and benefits shall be paid or denied in accordance with the decision."

Iowa Admin. Code r. 871-24.35(1) provides:

- 1. Except as otherwise provided by statute or by division rule, any payment, appeal, application, request, notice, objection, petition, report or other information or document submitted to the division shall be considered received by and filed with the division:
- (a) If transmitted via the United States Postal Service on the date it is mailed as shown by the postmark, or in the absence of a postmark the postage meter mark of the envelope in which it is received; or if not postmarked or postage meter marked or if the mark is illegible, on the date entered on the document as the date of completion.
- (b) If transmitted via the State Identification Date Exchange System (SIDES), maintained by the United States Department of Labor, on the date it was submitted to SIDES.
- (c) If transmitted by any means other than [United States Postal Service or the State Identification Data Exchange System (SIDES)], on the date it is received by the division.

Iowa Admin. Code r. 871-24.35(2) provides:

2. The submission of any payment, appeal, application, request, notice, objection, petition, report or other information or document not within the specified statutory or regulatory period shall be considered timely if it is established to the satisfaction of the division that the delay in submission was due to division error or misinformation or to delay or other action of the United States postal service.

The lowa Supreme Court has declared that there is a mandatory duty to file appeals from representatives' decisions within the time allotted by statute, and that the administrative law judge has no authority to change the decision of a representative if a timely appeal is not filed. *Franklin v. IDJS*, 277 N.W.2d 877, 881 (Iowa 1979). Compliance with appeal notice provisions is jurisdictional unless the facts of a case show that the notice was invalid. *Beardslee v. IDJS*, 276 N.W.2d 373, 377 (Iowa 1979); see also *In re Appeal of Elliott* 319 N.W.2d 244, 247 (Iowa 1982).

Here, the claimant received the decision in the mail and, therefore, had an opportunity to file an appeal prior to the appeal deadline. The delay was not due to an error or misinformation from the Department or due to delay or other action of the United States Postal Service. No other good cause reason has been established for the delay. The claimant's appeal was not filed on time and the administrative law judge lacks jurisdiction to decide the other issue in this matter.

## **DECISION:**

The January 26, 2023, (reference 03) unemployment insurance decision is AFFIRMED. The appeal in this case was not timely, and the decision of the representative remains in effect.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

#### AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

**Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
