STATEMENT OF THE CASE:

On December 8, 2022, Casey's Marketing Company (employer) filed an appeal from the statement of charges dated November 9, 2022, reference 04, for the third quarter of 2022. A hearing was scheduled for 8:00 a.m. on Tuesday, January 17, 2023, pursuant to due notice. However, the administrative record contained sufficient information to render a decision without a hearing. Therefore, no hearing was held.

ISSUES:

Was the employer's protest timely? Was the employer's appeal from the statement of charges timely?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: The claimant separated from employment in a prior claim year with an effective date of May 2, 2021. The administrative record shows that claimant last earned wages with this employer in the third quarter of 2021. The notice of claim was provided to the employer through the online SIDES system, and the employer responded to that notice of claim. Iowa Workforce Development ("IWD") then issued an unemployment insurance decision dated October 4, 2021 (reference 04) stating claimant was allowed benefits based on a quit from employment.

Next, claimant opened a claim in a second benefit year with an effective date of July 31, 2022. A second notice of claim was not provided to the employer. The first notice of the claimant's claim for benefits was the receipt of the statement of charges mailed November 9, 2022 for the third quarter of 2022. The employer filed its appeal of that statement of charges on December 9, 2022.

The issue of whether the claimant's separation has been adjudicated in a prior claim year has not yet been adjudicated by the IWD Benefits Bureau.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes the employer timely appealed the statement of charges.

lowa Code section 96.6(2) provides, in pertinent part:

2. Initial determination. A representative designated by the director shall promptly notify all interested parties to the claim of its filing, and the parties have ten days from the date of mailing the notice of the filing of the claim by ordinary mail to the last known address to protest payment of benefits to the claimant.

Iowa Code section 96.7(2)a(6) provides:

2. Contribution rates based on benefit experience.

a. (6) Within forty days after the close of each calendar quarter, the department shall notify each employer of the amount of benefits charged to the employer's account during that quarter. The notification shall show the name of each individual to whom benefits were paid, the individual's social security number, and the amount of benefits paid to the individual. An employer which has not been notified as provided in section 96.6, subsection 2, of the allowance of benefits to an individual, *may within thirty days after the date of mailing of the notification appeal to the department for a hearing to determine the eligibility of the individual to receive benefits.* The appeal shall be referred to an administrative law judge for hearing and the employer and the individual shall receive notice of the time and place of the hearing. (Emphasis added.)

Iowa Admin. Code r. 871-26.4 provides, in relevant part:

2. An appeal from an initial decision concerning the allowance or denial of benefits shall be filed, by mail, facsimile, or e-mail, online, or in person, not later than ten calendar days, as determined by the postmark or the date stamp after the decision was mailed to the party at its last-known address and shall state the following:

- a. The name, address and social security number of the claimant;
- b. A reference to the decision from which appeal is taken; and,
- c. The grounds upon which the appeal is based.

3. Notwithstanding the provisions of subrule 26.4(2), a contributory employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 30 days from the mailing date of the quarterly statement of benefit charges.

4. Also notwithstanding the provisions of subrule 26.4(2), a reimbursable employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 15 days of the mailing date of the quarterly billing of benefit charges.

An employer may appeal a claimant's eligibility for benefits through the quarterly statement of charges in cases where that employer has not previously received notice of the filing of a valid

claim for unemployment insurance benefits. See Iowa Code § 96.7(2)a(6). Here, the employer did not receive a notice of claim at the outset of the claimant's second benefit year. Therefore, its timely appeal of the second quarter statement of charges is appropriate.

This matter will be remanded to the Benefits Bureau, to review the claim history and to issue a prior adjudication decision consistent with the reference 04 decision in the May 2, 2021 claim year.

DECISION:

The November 9, 2022, reference 04, statement of charges for the third quarter of 2022 is affirmed, pending the outcome of the remanded issue. The employer has filed a timely and appropriate appeal from that statement of charges, as the notice of claim was not received.

REMAND:

This matter is remanded to the Benefits Bureau, to review the claim history and to issue a prior adjudication decision consistent with the reference 04 decision in the May 2, 2021 claim year.

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

1) The name, address, and social security number of the claimant.

2) A reference to the decision from which the appeal is taken.

3) That an appeal from such decision is being made and such appeal is signed.

4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at lowa Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf or by contacting the District Court Clerk of Court https://www.iowacourts.gov/iowa-courts/court-directory/.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
