STATEMENT OF THE CASE:

The employer filed a timely appeal from an unemployment insurance decision dated May 4, 2005, reference 02, which allowed benefits to the claimant. Prior to the date of the hearing, the employer requested that the appeal be withdrawn.

FINDINGS OF FACT:
