If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds. It is important that you file your claim as directed, while this appeal is pending, to protect your continuing right to benefits.

871IAC26.8(1) - Withdrawal of Appeal

STATEMENT OF THE CASE:

The employer/appellant filed a timely appeal from a representative's decision dated March 17, 2004, reference 02. A hearing was scheduled for June 8, 2005. Prior to the hearing being held, the appellant requested the appeal be withdrawn.

FINDINGS OF FACT:

The administrative law judge, having considered the evidence in the record, finds that: A request has been made by the appealing party to withdraw the appeal. The request has been submitted verbally and tape-recorded.

REASONING AND CONCLUSIONS OF LAW:

871 IAC 26.8(1) provides:

(1) An appeal may be withdrawn at any time prior to the issuance of a decision upon the request of the appellant and with the approval of the presiding officer to whom the case is assigned. Requests for withdrawal may be made in writing or orally, provided the oral request is tape-recorded by the presiding officer.

The administrative law judge has reviewed the records and files herein and concludes that the request of the appealing party to withdraw the appeal should be approved.

DECISION:

The March 17, 2004, reference 02, decision is affirmed. The request of the appealing party to withdraw the appeal is approved, and the decision of the representative allowing benefits to the claimant, while not charging the account of R J Personnel, shall stand and remain in full force and effect.
