STATEMENT OF THE CASE:

On November 19, 2021, employer LEP Logistics, Inc., filed an appeal from the statement of charges dated November 9, 2021 (reference 09) for the third quarter of 2021. A hearing was held at 1:00 p.m. on Wednesday, June 29, 2022, pursuant to due notice. Claimant Timothy J. Hubbard did not respond to the hearing notice and did not participate. The employer participated through Laurie Packer, Vice President. The department's Exhibits D-1 through D-4 were received and admitted.

ISSUES:

Was the employer's protest timely?
Was the employer's appeal from the statement of charges timely?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: The notice of claim was mailed to predecessor employer Goodwin Enterprises' address of record on May 11, 2021. Goodwin Enterprises did not respond to the notice of claim. On August 9, 2021, Iowa Workforce Development issued a decision to employer LEP Logistics, Inc. ("LEP"), transferring the experience of Goodwin Enterprises to LEP's account and holding LEP liable for any debts Goodwin Enterprises may owe to the agency. (Exhibit D-2) LEP did not appeal that decision.

Next, LEP received a statement of charges dated November 9, 2021 for the third quarter of 2021. LEP filed its appeal of that statement of charges on November 19, 2021, stating it should not be liable for benefits due to the circumstances leading to the end of claimant's employment.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes the employer did not timely file its appeal to the statement of charges.

Iowa Code section 96.6(2) provides, in pertinent part:

2. Initial determination. A representative designated by the director shall promptly notify all interested parties to the claim of its filing, and the parties have ten days from the date of mailing the notice of the filing of the claim by ordinary mail to the last known address to protest payment of benefits to the claimant.

Iowa Code section 96.7(2)a(6) provides:

- 2. Contribution rates based on benefit experience.
- a. (6) Within forty days after the close of each calendar quarter, the department shall notify each employer of the amount of benefits charged to the employer's account during that quarter. The notification shall show the name of each individual to whom benefits were paid, the individual's social security number, and the amount of benefits paid to the individual. An employer which has not been notified as provided in section 96.6, subsection 2, of the allowance of benefits to an individual, may within thirty days after the date of mailing of the notification appeal to the department for a hearing to determine the eligibility of the individual to receive benefits. The appeal shall be referred to an administrative law judge for hearing and the employer and the individual shall receive notice of the time and place of the hearing. [Emphasis added.]

Iowa Admin. Code r. 871-26.4 provides, in relevant part:

- 2. An appeal from an initial decision concerning the allowance or denial of benefits shall be filed, by mail, facsimile, or e-mail, online, or in person, not later than ten calendar days, as determined by the postmark or the date stamp after the decision was mailed to the party at its last-known address and shall state the following:
- a. The name, address and social security number of the claimant;
- b. A reference to the decision from which appeal is taken; and,
- c. The grounds upon which the appeal is based.
- 3. Notwithstanding the provisions of subrule 26.4(2), a contributory employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 30 days from the mailing date of the quarterly statement of benefit charges.
- 4. Also notwithstanding the provisions of subrule 26.4(2), a reimbursable employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 15 days of the mailing date of the quarterly billing of benefit charges.

An employer is only allowed to appeal to the department for a hearing to determine the eligibility of the individual to receive benefits if they were not previously notified pursuant to lowa Code section 96.6(2) of the notice of claim. In this case, the employer did receive the notice of claim and responded that it was not protesting. As such, the conditions for appealing the statement of charges under lowa Code section 96.7(2)a(6) have not been met. As the successor employer to Goodwin Enterprises, LEP has taken on all of the debts, actions, and inactions of its predecessor. Here, because Goodwin Enterprises failed to timely respond to the notice of claim upon receiving notice, successor LEP cannot now take a second bite at the proverbial apple

and benefit from an additional opportunity to protest the claim. The statement of charges will be affirmed.

DECISION:

The November 9, 2021 (reference 09) statement of charges for the third quarter of 2021 is affirmed. The employer did not timely file a timely protest to the notice of claim, and it has not met the conditions for appealing the statement of charges under the law.

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday. There is no filing fee to file an appeal with the Employment Appeal Board.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may file a petition for judicial review in district court.

2. If you do not file an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at www.iowacourts.gov/efile. There may be a filing fee to file the petition in District Court.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
