STATEMENT OF THE CASE:

On March 31, 2023, the claimant filed an appeal from the March 29, 2023, (reference 05) unemployment insurance decision that allowed benefits effective March 26, 2023, based upon a determination that claimant initially failed to provide verification of her identity but subsequently did so. Claimant was notified of the hearing scheduled for April 17, 2023. On April 13, 2023, claimant requested a continuance of the hearing because she was starting a new job the date of the hearing. The request was granted, and after due notice was issued, a telephone hearing was held on April 28, 2023. Claimant participated. Claimant's Exhibits A – D were received. Official notice was taken of the administrative record.

ISSUE:

Is the claimant able to and available for work?
Did the claimant timely provide verification of her identity?
Did the claimant fail to report as directed by a department representative?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Claimant filed a claim for unemployment insurance benefits effective February 26, 2023. Claimant was unable to verify her identity through the online verification process. Therefore, on the claim confirmation page, a notice appeared stating claimant was required to provide qualifying proof of identity to the agency in order to prevent benefits from being delayed and the claim from being canceled. Claimant did not recall seeing this message.

Additionally, on March 6, 2023, the agency mailed claimant a letter also stating that if claimant was unable to provide proof of identity by March 12, 2023, "benefits may be delayed and ... claim may be canceled."

Claimant received the notice and provided a copy of her social security card and driver's license on March 8, 2023, through the link provided in the March 6, 2023, letter. Claimant did not receive any notice from Iowa Workforce Development (IWD) telling her that the documentation did not go through or was insufficient. On March 23, 2023, IWD emailed claimant to notify her it did not receive proof of identity and requested she submit it. Claimant again provided the same documentation. On March 30, 2023, IWD notified claimant she needed to provide identification documentation, and claimant provided it for a third time.

IWD unlocked claimant's claim on March 31, 2023. The same day, the agency issued a decision finding claimant eligible for benefits effective March 26, 2023.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes claimant provided timely verification of identity.

Iowa Code section 96.4(3) provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work...

Iowa Code section 96.6 provides in relevant part:

1. Filing. Claims for benefits shall be made in accordance with such regulations as the department may prescribe.

Iowa Admin. Code r. 871-24.3 provides:

A claim will not become valid until the identity of the claimant has been verified by the department.

- (1) Upon the filing of a claim, notification shall be provided to the claimant if the claimant's identity was not verified.
- (2) If the agency is unable to verify the claimant's identity in the claim application, the claimant must provide approved documents. Approved documents must include at least one document containing a social security number. The department shall determine the approved documents required to verify identity. The list of approved documents can be found at the nearest local workforce center or online.
- (3) The claimant's identity will not be considered verified until approved documents have been provided. The claim shall remain locked from issuance of benefits until the claimant has provided the approved documents to verify identity.
- (4) After filing a claim application, the claimant shall not be eligible for benefits for any week until approved documents are provided to verify identity.

- (5) Approved documents must be provided or postmarked by Saturday at 11:59 p.m. of the week in which the approved documentation is due, and the claim shall be unlocked for all weeks following the most recent effective date of the claim application.
- (6) If required documents are provided in any subsequent weeks following the due date, the claimant shall be eligible, provided there are no other outstanding issues with the claim, as of the Sunday of the week the claimant's identity was verified.

Iowa Admin. Code r. 871-24.23(11) provides:

Availability disqualifications. The following are reasons for a claimant being disqualified for being unavailable for work.

(11) Failure to report as directed to workforce development in response to the notice which was mailed to the claimant will result in the claimant being deemed not to meet the availability requirements.

When filing an initial or additional claim, claimants are required to go through an identity verification process. If a claimant's identity is not verified during the application process IWD also mails a notice to the claimant one business day after the claim application is processed. This notice again notifies them that their identity was not verified. That notice also warns them that failure to verify their identity will result in benefits being delayed or the claim being cancelled; provides information on how to verify their identity; and gives a deadline for doing so.

In this case, Iowa Workforce Development notified claimant that identity verification needed to be provided by March 12, 2023, in order to prevent benefits from being delayed or the claim being cancelled. Claimant provided the approved documentation on March 8, 2023, prior to the March 12, 2023, deadline. Claimant did not receive any notification from IWD that her documentation was not received or that there were any issues with the documents she submitted. Claimant regularly checks her mail and email, including her spam folder. After IWD notified claimant on March 23, 2023, that it had not received her documentation, claimant resubmitted the same documentation again. Claimant similarly provided the same requested documentation in response to a March 30, 2023, message form IWD. The administrative law judge finds claimant did submit the correct documentation prior to the deadline. As such, benefits are allowed effective February 26, 2023, provided claimant is otherwise eligible.

DECISION:

The March 29, 2023, (reference 05) unemployment insurance decision is modified. Claimant provided approved proof of her identity. Benefits are allowed effective February 26, 2023, provided claimant is otherwise eligible.

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at lowa Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf or by contacting the District Court Clerk of Court https://www.iowacourts.gov/iowa-courts/court-directory/.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
