Section 96.4-3 – Active Search for Work

STATEMENT OF THE CASE:

Murray Auguste (claimant) an unemployment insurance decision dated February 17, 2004, reference 02, which issued him a warning for not making a minimum of two in-person job contacts during the week ending February 14, 2004. After a hearing notice was mailed to the claimant's last-known address of record, a telephone hearing was held on March 23, 2004. The claimant participated in the hearing.

FINDINGS OF FACT:

The administrative law judge, having reviewed and considered the evidence in the record, finds that: The claimant established a claim for unemployment insurance benefits during the week of January 4, 2004. He understood that each week he filed a claim for unemployment insurance benefits, he was required to make a minimum of two in-person job contacts. During the week

ending February 14, 2004, he made only one in-person job contact because he found a parttime job.

REASONING AND CONCLUSIONS OF LAW:

The issue is whether the claimant is actively and earnestly seeking work. Before a claimant is considered eligible to receive weekly unemployment insurance benefits, he must make an active search for work. Iowa Code Section 96.4-3. The administrative rule states an individual shall be ineligible for benefits for any period for which the department finds the individual failed to make an earnest and active search for work. An individual must make a sincere effort to find a job. 871 IAC 24.22(3).

The claimant testified that he failed to make two in-person searches because he was working part time. The evidence indicates the claimant was actively looking for work during the week ending February 14, 2004. Accordingly, the warning shall be rescinded.

DECISION:

The unemployment insurance decision dated February 17, 2004, reference 02, is reversed. The claimant made two in-person job contacts for the week ending February 14, 2004, and the warning shall be rescinded.
