871 IAC 26.8(1) – Withdrawal of Appeal

STATEMENT OF THE CASE:

The employer filed a timely appeal from an unemployment insurance decision dated May 16, 2003, reference 01, which allowed benefits to Julie E. Dobraska. Due notice was issued for a telephone hearing to be held October 5, 2004. At the time of the hearing, the employer requested to withdraw its appeal.

FINDINGS OF FACT:

Having examined all matters of record, the administrative law judge finds: The employer, the appellant in this matter, has requested that the appeal be withdrawn.

REASONING AND CONCLUSIONS OF LAW:

A rule found 871 IAC 26.8(1) allows the administrative law judge to grant an appellant's request for the withdrawal of its appeal. A review of all matters of record persuades the administrative law judge that it is appropriate to allow the withdrawal of this appeal.

DECISION:

The unemployment insurance decision dated May 16, 2003, reference 01, remains in effect as if no appeal had been filed. The claimant is entitled to receive unemployment insurance benefits, provided she is otherwise eligible.
