Section 96.5-2-a - Discharge

STATEMENT OF THE CASE:

The employer appealed an unemployment insurance decision dated August 12, 2005, reference 01, that concluded the claimant's discharge was not for work-connected misconduct. A telephone hearing was held on September 6, 2005. The parties were properly notified about the hearing. The claimant participated in the hearing. Cindy Simmers participated in the hearing on behalf of the employer with a witness, Dan McKinney.

FINDINGS OF FACT:

The claimant worked full time for the employer as a maintenance worker from January 30, 2004 to July 23, 2005. The claimant was informed and understood that under the employer's work rules, sexual harassment was prohibited including comments of a sexual nature.

On July 16, 2005, the clamant was in the break room with a female co-worker and a female supervisor. The women were talking about cellular phone providers when the co-worker's cellular phone, which was on vibrate mode, went off. The claimant jokingly asked the co-worker if she carried her vibrator with her all the time and if she loved herself that much. He did not intend the comment as a sexual comment but as a reference to the cell phone as a massager. The employee and the supervisor felt the comment was intended as a sexual comment but did not respond to the comment. The employee later told the supervisor that the comment made her uncomfortable. An investigation was conducted regarding the comment.

On July 23, 2005, the store manager told the claimant that he was being discharged from violating the store's sexual harassment policy as a result of the comment made on July 16. The claimant had never been counseled or warned about any similar conduct in the past.

REASONING AND CONCLUSIONS OF LAW:

The issue in this case is whether the claimant was discharged for work-connected misconduct as defined by the unemployment insurance law.

Iowa Code section 96.5-2-a provides:

An individual shall be disqualified for benefits:

- 2. Discharge for misconduct. If the department finds that the individual has been discharged for misconduct in connection with the individual's employment:
- a. The individual shall be disqualified for benefits until the individual has worked in and has been paid wages for insured work equal to ten times the individual's weekly benefit amount, provided the individual is otherwise eligible.

871 IAC 24.32(1)a provides:

Discharge for misconduct.

- (1) Definition.
- a. "Misconduct" is defined as a deliberate act or omission by a worker which constitutes a material breach of the duties and obligations arising out of such worker's contract of employment. Misconduct as the term is used in the disqualification provision as being limited to conduct evincing such willful or wanton disregard of an employer's interest as is found in deliberate violation or disregard of standards of behavior which the employer has the right to expect of employees, or in carelessness or negligence of such degree of recurrence as to manifest equal culpability, wrongful intent or evil design, or to show an intentional and substantial disregard of the employer's interests or of the employee's duties and obligations to the employer. On the other hand mere inefficiency, unsatisfactory conduct, failure in good performance as the result of inability or incapacity, inadvertencies or ordinary negligence in isolated instances, or good faith errors in judgment or discretion are not to be deemed misconduct within the meaning of the statute.

This definition has been accepted by the Iowa Supreme Court as accurately reflecting the intent of the legislature. <u>Huntoon v. Iowa Department of Job Service</u>, 275 N.W.2d 445, 448 (Iowa 1979).

The employer has the burden to prove the claimant was discharged for work-connected misconduct as defined by the unemployment insurance law. Cosper v. Iowa Department of Job Service, 321 N.W.2d 6 (Iowa 1982). The propriety of a discharge is not at issue in an unemployment insurance case. An employer may be justified in discharging an employee, but the employee's conduct may not amount to misconduct precluding the payment of unemployment compensation. The law limits disqualifying misconduct to substantial and willful wrongdoing or repeated carelessness or negligence that equals willful misconduct in culpability. Lee v. Employment Appeal Board, 616 N.W.2d 661, 665 (Iowa 2000).

The findings of fact show how I resolved the disputed factual issues in this case by carefully assessing the credibility of the witnesses and reliability of the evidence and by applying the proper standard and burden of proof. While the employer may have been justified in discharging the claimant, work-connected misconduct as defined by the unemployment insurance law has not been established. No willful or substantial misconduct has been proven in this case.

DECISION:

The unemployment insurance decision dated August 12, 2005, reference 01, is affirmed. The claimant is qualified to receive unemployment insurance benefits, if he is otherwise eligible.
