Section 96.4-3 - Able and Available

STATEMENT OF THE CASE:

Claimant filed an appeal from a decision of a representative dated March 3, 2006, reference 01, which held claimant not able and available for work. After due notice, a telephone conference hearing was scheduled for and held on March 29, 2006. Claimant participated personally. Employer participated by Dean Kloewer, President.

FINDINGS OF FACT:

The administrative law judge, having heard the testimony and considered all of the evidence in the record, finds: Claimant worked as a driver and terminal supervisor. Claimant was laid off February 9, 2006 because he lost his commercial driver's license due to an arrest for OWI.

Claimant's job is being held by the employer until claimant gets his license back. Claimant cannot perform the driver's part of his job without the commercial driver's license.

#### REASONING AND CONCLUSIONS OF LAW:

The issue in this matter is whether claimant is able and available for work.

Iowa Code Section 96.4-3 provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work. This subsection is waived if the individual is deemed partially unemployed, while employed at the individual's regular job, as defined in section 96.19, subsection 38, paragraph "b", unnumbered paragraph 1, or temporarily unemployed as defined in section 96.19, subsection 38, paragraph "c". The work search requirements of this subsection and the disqualification requirement for failure to apply for, or to accept suitable work of section 96.5, subsection 3 are waived if the individual is not disqualified for benefits under section 96.5, subsection 1, paragraph "h".

Inasmuch as claimant was hired in part as a driver and he now is prohibited from driving, he is not able and available for his job. Benefits are withheld until such time as the claimant obtains a full commercial driver's license and offers himself for further work with this employer. Benefits shall be withheld effective February 12, 2006.

#### DECISION:

The decision of the representative dated March 3 2006, reference 01, is modified. Claimant is not eligible to receive unemployment insurance benefits, effective February 12, 2006, provided claimant meets all other eligibility requirements.
