Section 96.5-1 – Voluntary Quit Section 96.3-7 – Recovery of Overpayment of Benefits

STATEMENT OF THE CASE:

Employer filed an appeal from a decision of a representative dated May 14, 2004, reference 01, which held claimant eligible for unemployment insurance benefits. After due notice, a telephone conference hearing was scheduled for and held on June 16, 2004. Claimant participated and was represented by Jay Hammond, Attorney at Law. Employer participated by Tim Dose, Superintendent and represented by Brett Nitzschke, Attorney at Law.

FINDINGS OF FACT:

The administrative law judge, having heard the testimony and considered all of the evidence in the record, finds: Claimant last worked for employer on May 27, 2004. Claimant separated employment from this employer May 27, 2004 under facts essentially identical to that of <u>Meyer</u> <u>v. Employment Appeal Board</u>, 441 N.W.2d 766 (Iowa1989). Claimant was paid through the last date. Claimant received unemployment benefits totaling \$1,485.00 from April 25, 2004 through the week ending May 29, 2004.

REASONING AND CONCLUSIONS OF LAW:

The issue in this matter is whether the claimant quit for good cause attributable to the employer. The administrative law judge holds that the evidence has established that claimant voluntarily quit for good cause attributable to the employer when claimant terminated the employment relationship effective May 27, 2004 with eligibility starting the week of May 30, 2004. <u>Meyer v.</u> <u>Employment Appeal Board</u>, 441 N.W.2d 766 (Iowa1989)

Iowa Code Section 96.5-1 provides:

An individual shall be disqualified for benefits:

1. Voluntary quitting. If the individual has left work voluntarily without good cause attributable to the individual's employer, if so found by the department.

The next issue concerns an overpayment of unemployment insurance benefits.

Iowa Code Section 96.3-7 provides:

7. Recovery of overpayment of benefits. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

The administrative law judge holds that claimant is overpaid unemployment insurance benefits in the amount of \$1,485.00 pursuant to Iowa Code Section 96.3-7 because a decision has determined claimant is ineligible to receive benefits due to a voluntary quit without good cause attributable to employer.

Since claimant has been disqualified for the receipt of unemployment insurance benefits, the claim shall be locked until claimant has requalified or is otherwise eligible.

DECISION:

The decision of the representative dated May 14, 2004, reference 01, is modified in favor of appellant. Unemployment insurance benefits are withheld through the week ending May 29, 2004. Unemployment insurance benefits are allowed provided claimant is otherwise eligible effective May 30, 2004. Claimant is overpaid unemployment insurance benefits in the amount of \$1,485.00.
