STATEMENT OF THE CASE:

On May 10, 2022, claimant Heather D. Thompson filed an appeal from the April 18, 2022 (reference 02) unemployment insurance decision that found the claimant was overpaid regular unemployment insurance benefits; Federal Pandemic Unemployment Compensation (“FPUC”) benefits; Federal Pandemic Emergency Unemployment Compensation (“PEUC”) benefits; and Lost Wages Assistance Program (“LWAP”) benefits. The parties were properly notified of the hearing. A telephonic hearing was held at 11:00 a.m. on Thursday, June 30, 2022. Appeal numbers 22A-UI-12402-LJ-T and 22A-UI-12403-LJ-T were heard together and created one record. The claimant, Heather D. Thompson, participated. Employer Vera French Community Mental Health did not participate in the hearing. The administrative law judge attempted to connect the employer but was unable to reach a person when calling the telephone number that had called in for the hearing. Department’s Exhibits D-1, D-2, and D-3 were received and admitted into the record without objection. The administrative law judge took official notice of the administrative record.

ISSUE:

Did the claimant file a timely appeal?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: The decision denying claimant benefits due to a work refusal was mailed to claimant's last known address of record on April 14, 2021. She maintains she did not receive this decision. The first sentence of the decision states, “If this decision denies benefits and is not reversed on appeal, it may result in an overpayment which you will be required to repay.” The decision contained a warning that an appeal must be postmarked or received by the Appeals Bureau by April 24, 2021. Because claimant did not receive the decision in April 2021, she did not file an appeal at that time.

Next, the decision finding claimant overpaid multiple types of benefits was mailed to her last known address of record on April 18, 2022. The decision contained a warning that an appeal must be postmarked or received by the Appeals Bureau by April 28, 2022. The appeal was not filed until May 10, 2022, which is after the date noticed on the disqualification decision.

Claimant did not receive the overpayment decision prior to the appeal deadline because she had been in Florida. She returned from Florida on April 30, 2022. However, she waited until the following Monday, May 2, to open the mail that had accumulated in her absence. Claimant then spent four days trying to contact an attorney. After an attorney advised her to file an appeal despite having missed the deadline, claimant waited another four days before filing her appeal online on May 10, 2022.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes claimant failed to file a timely appeal.

Iowa Code § 96.6(2) provides, in pertinent part: “[u]nless the claimant or other interested party, after notification or within ten calendar days after notification was mailed to the claimant's last known address, files an appeal from the decision, the decision is final and benefits shall be paid or denied in accordance with the decision.”

Iowa Admin. Code r. 871-24.35(1) provides:

1. Except as otherwise provided by statute or by division rule, any payment, appeal, application, request, notice, objection, petition, report or other information or document submitted to the division shall be considered received by and filed with the division:

(a) If transmitted via the United States Postal Service on the date it is mailed as shown by the postmark, or in the absence of a postmark the postage meter mark of the envelope in which it is received; or if not postmarked or postage meter marked or if the mark is illegible, on the date entered on the document as the date of completion.

(b) If transmitted via the State Identification Data Exchange System (SIDES), maintained by the United States Department of Labor, on the date it was submitted to SIDES.

(c) If transmitted by any means other than [United States Postal Service or the State Identification Data Exchange System (SIDES)], on the date it is received by the division.

Iowa Admin. Code r. 871-24.35(2) provides:


2. The submission of any payment, appeal, application, request, notice, objection, petition, report or other information or document not within the specified statutory or regulatory period shall be considered timely if it is established to the satisfaction of the division that the delay in submission was due to division error or misinformation or to delay or other action of the United States postal service.

The Iowa Supreme Court has declared that there is a mandatory duty to file appeals from representatives' decisions within the time allotted by statute, and that the administrative law judge has no authority to change the decision of a representative if a timely appeal is not filed. *Franklin v. IDJS*, 277 N.W.2d 877, 881 (Iowa 1979). Compliance with appeal notice provisions is jurisdictional unless the facts of a case show that the notice was invalid. *Beardslee v. IDJS*, 276 N.W.2d 373, 377 (Iowa 1979); see also *In re Appeal of Elliott* 319 N.W.2d 244, 247 (Iowa 1982).

Here, the claimant did not receive the decision prior to the deadline due to personal travel. She then delayed opening her mail and delayed filing her appeal once she received advice from an attorney. Claimant failed to provide a reasonable explanation for either of these delays, and the administrative law judge finds them unjustified. Claimant's delay was not due to an error or misinformation from the Department or due to delay or other action of the United States Postal Service. No other good cause reason has been established for the delay. Claimant's appeal was not filed on time and the administrative law judge lacks jurisdiction (authority) to decide the other issue in this matter.

DECISION:

The April 18, 2022, (reference 02) unemployment insurance decision is affirmed. The appeal in this case was not timely, and the decision of the representative remains in effect.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at <https://www.legis.iowa.gov/docs/code/17A.19.pdf> or by contacting the District Court Clerk of Court <https://www.iowacourts.gov/iowa-courts/court-directory/>.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.

2.
