# STATEMENT OF THE CASE:

Ozark Automotive Distributors Inc, the employer/appellant, filed an appeal from the Iowa Workforce Development (IWD) July 25, 2022 (reference 01) unemployment insurance (UI) decision that allowed UI benefits because of a non-disqualifying June 27, 2022 discharge from work. The parties were properly notified of the hearing. A telephone hearing was held on September 7, 2022. The employer participated through Julie Akers, human resources business partner and Scott Hall, distribution center manager.. Ms. Dizdarevic did not participate in the hearing. The administrative law judge took official notice of the administrative record.

## ISSUE:

Did the employer discharge Ms. Dizdarevic from employment for disqualifying, job-related misconduct, or did she voluntarily quit without good cause attributable to the employer?

# **FINDINGS OF FACT:**

Having reviewed the evidence in the record, the administrative law judge finds: Ms. Dizdarevic began working for the employer on April 15, 2022. She worked as a full-time returns material handler. Her employment ended on June 24, 2022.

The employer's policy provides that employee who do not attend work and do not call-in will receive a warning and employees who do not attend work and do not call-in for three consecutive scheduled shifts are considered to have voluntarily resigned. Ms. Dizdarevic acknowledged receiving a copy of the policy on her hire date.

Ms. Dizdarevic was a No-Call/No-Show on May 31, 2022. The employer gave her a warning on June 1 for the May 31 No-Call/No-Show. Ms. Dizdarevic was a No-Call/No-Show again on June 9. The employer gave her a final warning on June 15 for the June 9 No-Call/No-Show. Ms. Dizdarevic was a No-Call/No-Show again on June 22, 23, and 24. The employer considered Ms. Dizdarevic to have voluntarily resigned as of June 24, 2022.

Ms. Dizdarevic has received REGULAR (state) UI benefits in the gross amount of \$2,400.00 between July 3, 2022 and August 13, 2022. The employer was ready to participate in the fact-finding interview but did not do so because IWD did not call the employer at the time scheduled for the interview.

## **REASONING AND CONCLUSIONS OF LAW:**

For the reasons that follow, the administrative law judge concludes Ms. Dizdarevic's separation from the employment was without good cause attributable to the employer.

Iowa Code section 96.5(1) provides:

An individual shall be disqualified for benefits:

1. Voluntary quitting. If the individual has left work voluntarily without good cause attributable to the individual's employer, if so found by the department.

Iowa Admin. Code r. 871-24.25(4) provides:

Voluntary quit without good cause. In general, a voluntary quit means discontinuing the employment because the employee no longer desires to remain in the relationship of an employee with the employer from whom the employee has separated. The employer has the burden of proving that the claimant is disqualified for benefits pursuant to lowa Code section 96.5. However, the claimant has the initial burden to produce evidence that the claimant is not disqualified for benefits in cases involving lowa Code section 96.5, subsection (1), paragraphs "a" through "i," and subsection 10. The following reasons for a voluntary quit shall be presumed to be without good cause attributable to the employer:

(4) The claimant was absent for three days without giving notice to employer in violation of company rule.

The claimant has the burden of proving that the voluntary leaving was for good cause attributable to the employer. Iowa Code § 96.6(2). "Good cause" for leaving employment must be that which is reasonable to the average person, not the overly sensitive individual or the claimant in particular. *Uniweld Products v. Indus. Relations Comm'n*, 277 So.2d 827 (Fla. Dist. Ct. App. 1973). A voluntary leaving of employment requires an intention to terminate the employment relationship accompanied by an overt act of carrying out that intention. *Local Lodge #1426 v. Wilson Trailer*, 289 N.W.2d 608, 612 (lowa 1980).

In this case, Ms. Dizdarevic did not attend work or call-in to work on June 22, 23 and 24. Ms. Dizdarevic voluntarily quit without good cause attributable to the employer. Benefits are denied.

The administrative law judge further concludes Ms. Dizdarevic has been overpaid REGULAR (state) UI benefits in the gross amount of \$2,400.00.

Iowa Code §96.3(7) provides, in pertinent part:

7. Recovery of overpayment of benefits.

- a. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.
- b. (1) (a) If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.
- (b) However, provided the benefits were not received as the result of fraud or willful misrepresentation by the individual, benefits shall not be recovered from an individual if the employer did not participate in the initial determination to award benefits pursuant to section 96.6, subsection 2, and an overpayment occurred because of a subsequent reversal on appeal regarding the issue of the individual's separation from employment.

Iowa Admin. Code r. 871-24.10 provides:

Employer and employer representative participation in fact-finding interviews.

- (1) "Participate," as the term is used for employers in the context of the initial determination to award benefits pursuant to lowa Code section 96.6, subsection 2, means submitting detailed factual information of the quantity and quality that if unrebutted would be sufficient to result in a decision favorable to the employer. The most effective means to participate is to provide live testimony at the interview from a witness with firsthand knowledge of the events leading to the separation. If no live testimony is provided, the employer must provide the name and telephone number of an employee with firsthand information who may be contacted, if necessary, for rebuttal. A party may also participate by providing detailed written statements or documents that provide detailed factual information of the events leading to separation. At a minimum, the information provided by the employer or the employer's representative must identify the dates and particular circumstances of the incident or incidents, including, in the case of discharge, the act or omissions of the claimant or, in the event of a voluntary separation, the stated reason for the quit. The specific rule or policy must be submitted if the claimant was discharged for violating such rule or policy. In the case of discharge for attendance violations, the information must include the circumstances of all incidents the employer or the employer's representative contends meet the definition of unexcused absences as set forth in 871—subrule 24.32(7). On the other hand, written or oral statements or general conclusions without supporting detailed factual information and information submitted after the fact-finding decision has been issued are not considered participation within the meaning of the statute.
- (2) "A continuous pattern of nonparticipation in the initial determination to award benefits," pursuant to lowa Code section 96.6, subsection 2, as the term is used for an entity representing employers, means on 25 or more occasions in a

calendar quarter beginning with the first calendar quarter of 2009, the entity files appeals after failing to participate. Appeals filed but withdrawn before the day of the contested case hearing will not be considered in determining if a continuous pattern of nonparticipation exists. The division administrator shall notify the employer's representative in writing after each such appeal.

- (3) If the division administrator finds that an entity representing employers as defined in Iowa Code section 96.6, subsection 2, has engaged in a continuous pattern of nonparticipation, the division administrator shall suspend said representative for a period of up to six months on the first occasion, up to one year on the second occasion and up to ten years on the third or subsequent occasion. Suspension by the division administrator constitutes final agency action and may be appealed pursuant to Iowa Code section 17A.19.
- (4) "Fraud or willful misrepresentation by the individual," as the term is used for claimants in the context of the initial determination to award benefits pursuant to lowa Code section 96.6, subsection 2, means providing knowingly false statements or knowingly false denials of material facts for the purpose of obtaining unemployment insurance benefits. Statements or denials may be either oral or written by the claimant. Inadvertent misstatements or mistakes made in good faith are not considered fraud or willful misrepresentation.

This rule is intended to implement Iowa Code section 96.3(7)"b" as amended by 2008 Iowa Acts, Senate File 2160.

Ms. Dizdarevic has been overpaid REGULAR (state) UI benefits in the gross amount of \$2,400.00 because she is not qualified and/or is ineligible to receive REGULAR (state) UI benefits based on her June 24, 2022 voluntary quit. Since the employer did not participate in the fact-finding interview, Ms. Dizdarevic is not required to repay the UI benefits.

# **DECISION:**

The July 25, 2022, (reference 01) UI decision is REVERSED. Ms. Dizdarevic voluntarily left her employment without good cause attributable to the employer. Benefits are withheld until such time as she has worked in and been paid wages for insured work equal to ten times her weekly benefit amount, provided she is otherwise eligible.

Ms. Dizdarevic has been overpaid REGULAR (state) UI benefits in the gross amount of \$2,400.00. Since the employer did not participate in the fact-finding interview, Ms. Dizdarevic is not required to repay these benefits.

## AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf or by contacting the District Court Clerk of Court\_https://www.iowacourts.gov/iowa-courts/court-directory/.

**Note to Parties:** YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

**Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
