## STATEMENT OF THE CASE:

Devany N. Soto Munoz, the claimant/appellant, filed an appeal from the Iowa Workforce Development (IWD) December 5, 2022, (reference 02) unemployment insurance (UI) decision. The decision denied REGULAR (state) UI benefits because IWD concluded the employer had discharged Ms. Soto Munoz from work on November 3, 2022 for not following instructions while doing her job. The Iowa Department of Inspections and Appeals UI Appeals Bureau mailed a notice of hearing to Ms. Soto Munoz and the employer. A telephone hearing was held on January 19, 2023. Ms. Soto Munoz participated personally. The employer participated through Kari Livermore, business manager. The administrative law judge took official notice of the administrative record.

## **ISSUE:**

Is. Ms. Soto Munoz's appeal filed on time?

Did the employer discharge Ms. Soto Munoz from work for disqualifying, job-related misconduct?

#### FINDINGS OF FACT:

Having reviewed the evidence in the record, the administrative law judge finds: IWD mailed the December 5, 2022, (reference 02) UI decision to Ms. Soto Munoz at the correct address on December 5, 2022. The UI decision states that it becomes final unless an appeal is postmarked or received by the IWD Appeals Section by Thursday, December 15, 2022.

Ms. Soto Munoz received the decision in the mail the evening of December 14, 2022. The next day, Ms. Soto Munoz called IWD. Ms. Soto Munoz was on hold for some time, and she hung up before an IWD representative answered. Ms. Soto Munoz called IWD a few more times that day and the next day and hung up each time before an IWD representative answered. At some point, Ms. Soto Munoz reached an IWD voice mailbox and left a call back number. On Monday, December 19, an IWD representative called Ms. Soto Munoz back and told her that she could

file an appeal online. Ms. Soto Munoz filed an appeal online on Monday, December 19, 2022. The appeal was received on December 19, 2022.

## **REASONING AND CONCLUSIONS OF LAW:**

For the reasons that follow, the administrative law judge concludes Ms. Soto Munoz's appeal of the December 5, 2022 (reference 02) UI decision was not filed on time.

lowa Code § 96.6(2) provides, in pertinent part: "[u]nless the claimant or other interested party, after notification or within ten calendar days after notification was mailed to the claimant's last known address, files an appeal from the decision, the decision is final and benefits shall be paid or denied in accordance with the decision."

Iowa Admin. Code r. 871-24.35(1) provides:

- 2. Except as otherwise provided by statute or by division rule, any payment, appeal, application, request, notice, objection, petition, report or other information or document submitted to the division shall be considered received by and filed with the division:
- (2) If transmitted via the United States Postal Service on the date it is mailed as shown by the postmark, or in the absence of a postmark the postage meter mark of the envelope in which it is received; or if not postmarked or postage meter marked or if the mark is illegible, on the date entered on the document as the date of completion.
- (b) If transmitted via the State Identification Date Exchange System (SIDES), maintained by the United States Department of Labor, on the date it was submitted to SIDES.
- (c) If transmitted by any means other than [United States Postal Service or the State Identification Data Exchange System (SIDES)], on the date it is received by the division.

Iowa Admin. Code r. 871-24.35(2) provides:

2. The submission of any payment, appeal, application, request, notice, objection, petition, report or other information or document not within the specified statutory or regulatory period shall be considered timely if it is established to the satisfaction of the division that the delay in submission was due to division error or misinformation or to delay or other action of the United States postal service.

The lowa Supreme Court has declared that there is a mandatory duty to file appeals from representatives' decisions within the time allotted by statute, and that the administrative law judge has no authority to change the decision of a representative if a timely appeal is not filed.<sup>1</sup> Compliance with appeal notice provisions is jurisdictional unless the facts of a case show that the notice was invalid.<sup>2</sup>

Ms. Soto Munoz received the December 5, 2022 (reference 02) UI decision before the appeal deadline and, therefore, could have filed an appeal by the deadline. The notice provision of the decision was valid. Ms. Soto Munoz's delay in filing her appeal was not due to an error or misinformation from the Department or due to delay or other action of the United States Postal Service. No other good cause reason has been established for the delay in filing her appeal. Ms. Soto Munoz's appeal of the December 5, 2022 (reference 02) UI decision was not filed on time and the administrative law judge lacks jurisdiction (authority) to decide the other issue in this matter.

# **DECISION:**

Ms. Soto Munoz's appeal of the December 5, 2022 (reference 02) UI decision was not filed on time. The December 5, 2022 (reference 02) UI decision denying REGULAR (state) UI benefits is AFFIRMED.

**APPEAL RIGHTS.** If you disagree with this decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

## AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

<u>2.</u> If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to <u>file a petition for judicial</u> <u>review in District Court</u> within thirty (30) days after the decision becomes final. **Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
