871 IAC 26.8(1) - Withdrawal of Appeal

#### STATEMENT OF THE CASE:

# 871 IAC 26.8(1) provides:

Requests for withdrawal may be made in writing or orally, provided the oral request is tape-recorded by the presiding officer.

The administrative law judge has reviewed the records and files herein and concludes that the request of the appealing party to withdraw the appeal should be approved.

## **DECISION:**

The decision of the representative dated June 23, 2006, reference 01, is affirmed. The request of the appealing party to withdraw the appeal is approved, and the decision of the representative shall stand and remain in full force and effect.
