STATEMENT OF THE CASE:

On November 29, 2022, Raining Rose Inc. (employer) filed an appeal from the statement of charges dated November 9, 2022, reference 10, for the third quarter of 2022. A hearing was scheduled at 8:00 a.m. on Tuesday, December 27, 2022, pursuant to due notice. Luis Ramos Ramirez (claimant) did not participate. The employer did, Raining Rose Inc., participate through Nikki Voss, Director of HR. The department's Exhibits D1 through D5 were admitted into the record.

ISSUES:

Did the employer file a timely appeal from the statement of charges? Has the claimant requalified for benefits since the separation?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Luis Ramos Ramirez (claimant) filed the claim for unemployment insurance benefits effective January 23, 2022, and the weekly benefit amount is \$531.00. Claimant opened his claim while still employed with this employer, when he was experiencing temporary unemployment due to personal illness. Iowa Workforce Development ("IWD") sent the employer a notice of claim (Exhibit D-1), and the employer replied with a completed protest stating claimant was still employed. (Exhibit D-2) Next, IWD issued the unemployment insurance decision dated February 10, 2022 (reference 01) stating claimant was not eligible for benefits because he was not able to work due to illness. (Exhibit D-3) Claimant returned to work on January 28, and he continued to work for the employer until March 8, when he separated from employment. The employer never received a second notice of claim following claimant's separation from employment.

Following claimant's separation, he became employed with employer Actalent Scientific LLC (account 350081). Claimant earned more than \$5,310.00 in insured wages– or more than ten times his weekly benefit amount of \$531.00 – between the time he separated from employment

with Raining Rose Inc. and he established an additional claim date of July 10, 2022, and began filing for unemployment insurance benefits and receiving benefits during his claim year.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes the employer filed a timely appeal from the statement of charges and the claimant has requalified for benefits. Benefits are allowed and the employer's account shall not be charged.

Iowa Code section 96.6(2) provides, in pertinent part:

2. Initial determination. A representative designated by the director shall promptly notify all interested parties to the claim of its filing, and the parties have ten days from the date of mailing the notice of the filing of the claim by ordinary mail to the last known address to protest payment of benefits to the claimant.

Iowa Code section 96.7(2)a(6) provides:

2. Contribution rates based on benefit experience.

a. (6) Within forty days after the close of each calendar quarter, the department shall notify each employer of the amount of benefits charged to the employer's account during that quarter. The notification shall show the name of each individual to whom benefits were paid, the individual's social security number, and the amount of benefits paid to the individual. An employer which has not been notified as provided in section 96.6, subsection 2, of the allowance of benefits to an individual, may within thirty days after the date of mailing of the notification appeal to the department for a hearing to determine the eligibility of the individual to receive benefits. The appeal shall be referred to an administrative law judge for hearing and the employer and the individual shall receive notice of the time and place of the hearing.

Iowa Admin. Code r. 871-26.4 provides, in relevant part:

2. An appeal from an initial decision concerning the allowance or denial of benefits shall be filed, by mail, facsimile, or e-mail, online, or in person, not later than ten calendar days, as determined by the postmark or the date stamp after the decision was mailed to the party at its last-known address and shall state the following:

- a. The name, address and social security number of the claimant;
- b. A reference to the decision from which appeal is taken; and,
- c. The grounds upon which the appeal is based.

3. Notwithstanding the provisions of subrule 26.4(2), a contributory employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 30 days from the mailing date of the quarterly statement of benefit charges.

4. Also notwithstanding the provisions of subrule 26.4(2), a reimbursable employer, which has not previously received a notice of the filing of a valid claim

for benefits, may appeal an individual's eligibility to receive benefits within 15 days of the mailing date of the quarterly billing of benefit charges.

The employer filed an appropriate appeal of the statement of charges because it did not receive a notice of claim following claimant's separation giving it an opportunity to protest the claimant's receipt of benefits chargeable to its account. The employer filed the appeal to the statement of charges within thirty days making the appeal timely. The claimant has requalified for benefits since the separation from this employer by earning ten times the weekly benefit amount in insured wages following the separation. *See* Iowa Code §§ 96.5(1)g and 96.5(2)a. Accordingly, benefits are allowed and the account of the employer shall not be charged.

DECISION:

The November 9, 2022, reference 10, statement of charges for the third quarter of 2022 is modified in favor of the appellant, which will appear as a credit to the employer's account on a future statement of charges. The employer has filed a timely and appropriate appeal from that statement of charges, as a notice of claim following claimant's separation was not received. The claimant has requalified for benefits since the separation and prior to receiving any benefits during the claim year. Benefits are allowed, provided the claimant is otherwise eligible. The account of the employer shall not be charged and a credit shall be issued on a future statement of charges.

2) A reference to the decision from which the appeal is taken.

3) That an appeal from such decision is being made and such appeal is signed.

4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at lowa Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf or by contacting the District Court Clerk of Court https://www.iowacourts.gov/iowa-courts/court-directory/.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
