STATEMENT OF THE CASE:

Pro Resources Inc, the employer/appellant, filed an appeal from the Iowa Workforce Development (IWD) December 29, 2022, (reference 01) unemployment insurance (UI) decision. The decision allowed Mr. Meike REGUALR (state) UI benefits because IWD concluded that the employer's protest was not filed on time. The Iowa Department of Inspections and Appeals UI Appeals Bureau mailed a notice of hearing to the employer and Mr. Meike. A telephone hearing was held on January 24, 2023. The employer participated through Jamie Wampler, corporate administrator. Mr. Meike participated personally. The administrative law judge took official notice of the administrative record and admitted Employer's Exhibit 1 as evidence.

ISSUES:

Is the employer's protest filed on time?

FINDINGS OF FACT:

Having reviewed the evidence in the record, the administrative law judge finds: IWD mailed Mr. Meike's notice of claim notice to the employer on December 9, 2022. The notice of claim contains a warning that the employer's protest response is due ten days from the initial notice date and gave a due date of December 19, 2022.

The employer did not receive the notice in the mail. On December 8, 2022, the employer had signed up for the IWD State Information Data Exchange System (SIDES) to receive notices of claim electronically. IWD sent the employer an email confirming registration and telling the employer that they would receive notices of claim electronically as of December 9, 2022. On December 14, Ms. Wampler tried to but was unable to log into SIDES. Ms. Wampler sent IWD an email that day and IWD responded to Ms. Wampler with login instructions. Ms. Wampler was teleworking that day through December 22 because of an ill family member, and she did not have access to all of her works systems so she could not log into SIDES. Ms. Wampler was off work December 23-26. Ms. Wampler returned to work on December 27. That day, Ms. Wampler completed, signed and submitted the notice electronically via SIDES. IWD received the notice of December 28, 2022.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes the employer did not file its protest of the December 9, 2022 notice on time.

lowa Code § 96.6(2) provides, in pertinent part: "[u]nless the claimant or other interested party, after notification or within ten calendar days after notification was mailed to the claimant's last known address, files an appeal from the decision, the decision is final, and benefits shall be paid or denied in accordance with the decision."

Iowa Admin. Code r. 871-24.35(1) provides:

- 1. Except as otherwise provided by statute or by division rule, any payment, appeal, application, request, notice, objection, petition, report or other information or document submitted to the division shall be considered received by and filed with the division:
- (a) If transmitted via the United States Postal Service on the date it is mailed as shown by the postmark, or in the absence of a postmark the postage meter mark of the envelope in which it is received; or if not postmarked or postage meter marked or if the mark is illegible, on the date entered on the document as the date of completion.
- (b) If transmitted via the State Identification Date Exchange System (SIDES), maintained by the United States Department of Labor, on the date it was submitted to SIDES.
- (c) If transmitted by any means other than [United States Postal Service or the State Identification Data Exchange System (SIDES)], on the date it is received by the division.

Iowa Admin. Code r. 871-24.35(2) provides:

2. The submission of any payment, appeal, application, request, notice, objection, petition, report or other information or document not within the specified statutory or regulatory period shall be considered timely if it is established to the satisfaction of the division that the delay in submission was due to division error or misinformation or to delay or other action of the United States postal service.

The Iowa Supreme Court has declared that there is a mandatory duty to file appeals from representatives' decisions within the time allotted by statute, and that the administrative law judge has no authority to change the decision of a representative if a timely appeal is not filed. *Franklin v. IDJS*, 277 N.W.2d 877, 881 (Iowa 1979). Compliance with appeal notice provisions is jurisdictional unless the facts of a case show that the notice was invalid. *Beardslee v. IDJS*, 276 N.W.2d 373, 377 (Iowa 1979); see also *In re Appeal of Elliott* 319 N.W.2d 244, 247 (Iowa 1982).

In this case, the employer received notice of the claim before the deadline and, therefore, could have filed a protest prior to the deadline. The notice provision of the notice was valid. On December 14, 2022 IWD told the employer how to access SIDES. Ms. Shenk did do so because she was tele-working for some days, and she was off work some days. The employer submitted its protest on December 27, 2022, which was after the December 19, 2022 deadline. The employer's protest was not filed on time.

DECISION:

The employer's protest of the December 9, 2022 notice was not filed on time. The December 29, 2022, (reference 01) decision is AFFIRMED.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

<u>2.</u> If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to <u>file a petition for judicial review in District Court</u> within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at lowa Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf or by contacting the District Court Clerk of Court https://www.iowacourts.gov/iowa-courts/court-directory/.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
