STATEMENT OF THE CASE:

Express Services (employer) appealed a representative's April 23, 2018, decision (reference 01) that concluded Jakob Hoadley (claimant) was eligible to receive unemployment insurance benefits. After hearing notices were mailed to the parties' last-known addresses of record, a telephone hearing was scheduled for May 18, 2018. The claimant did not provide a telephone number for the hearing and, therefore, did not participate. The employer participated by Nikki Danzer, Staffing Consultant. Exhibit D-1 was received into evidence.

ISSUE:

The issue is whether the claimant was separated from employment for any disqualifying reason.

FINDINGS OF FACT:

The administrative law judge, having heard the testimony and considered all of the evidence in the record, finds that: The employer is a temporary employment service. The claimant performed services from October 2, 2017, through October 13, 2017. He signed a document on September 29, 2017, indicating he was to contact the employer within three business days following the completion of an assignment to request placement in a new assignment. The document indicated the consequences of a failure to notify the employer. The claimant was not given a copy of the document.

On September 29, 2017, the claimant also electronically signed for receipt of the employer's handbook. It indicated he was to contact the employer within forty-eight hours of the end of his assignment or seventy-two hours as mandated by state law.

The claimant was supposed to go out of town to work for the week of October 16, 2017. He notified his supervisor that he could not leave town due to an emergency. The employer considered him to have quit work when he did not go out of town. The claimant completed his last assignment on October 13, 2017, but did not seek reassignment from the employer.

The claimant filed for unemployment insurance benefits with an effective date of April 23, 2018. The employer participated personally at the fact finding interview on April 20, 2018, by Tori Platts.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow the administrative law judge concludes the claimant was not separated from employment for a disqualifying reason.

Iowa Code section 96.5(1)j provides:

An individual shall be disqualified for benefits, regardless of the source of the individual's wage credits:

1. Voluntary quitting. If the individual has left work voluntarily without good cause attributable to the individual's employer, if so found by the department. But the individual shall not be disqualified if the department finds that:

j. (1) The individual is a temporary employee of a temporary employment firm who notifies the temporary employment firm of completion of an employment assignment and who seeks reassignment. Failure of the individual to notify the temporary employment firm of completion of an employment assignment within three working days of the completion of each employment assignment under a contract of hire shall be deemed a voluntary quit unless the individual was not advised in writing of the duty to notify the temporary employment firm upon completion of an employment assignment or the individual had good cause for not contacting the temporary employment firm within three working days and notified the firm at the first reasonable opportunity thereafter.

(2) To show that the employee was advised in writing of the notification requirement of this paragraph, the temporary employment firm shall advise the temporary employee by requiring the temporary employee, at the time of employment with the temporary employment firm, to read and sign a document that provides a clear and concise explanation of the notification requirement and the consequences of a failure to notify. The document shall be separate from any contract of employment and a copy of the signed document shall be provided to the temporary employee.

(3) For the purposes of this paragraph:

(a) "Temporary employee" means an individual who is employed by a temporary employment firm to provide services to clients to supplement their workforce during absences, seasonal workloads, temporary skill or labor market shortages, and for special assignments and projects.

(b) "Temporary employment firm" means a person engaged in the business of employing temporary employees.

Under the Iowa Code the employer must advise the claimant of the three working day notice requirement and give the claimant a copy of that requirement. The notice requirement must be separate from the contract for hire. The employer had the claimant sign conflicting notice requirements. The claimant was separated from his assignment and he did not seek reassignment. It did not provide the claimant with the proper notice requirements and has,

therefore, failed to satisfy the requirements of Iowa Code Section 96.5-1-j. Benefits are allowed, provided the claimant is otherwise eligible.

DECISION:

The representative's April 23, 2018, decision (reference 01) is affirmed. The claimant was separated from the employer for good cause attributable to the employer. Benefits are allowed, provided the claimant is otherwise eligible.
