Section 96.3-7 - Recovery of Overpayment of Benefits

STATEMENT OF THE CASE:

Joseph L. Fountain (claimant) appealed a representative's August 12, 2009 decision (reference 03) that held him overpaid \$9,666.08 in benefits he received between February 1 and July 18, 2009. The overpayment occurred as the result of a July 22, 2009 decision that denied the claimant's request to add wages he earned in Missouri from April 1 through September 30, 2008, to his Iowa claim. After a hearing notice was mailed to the claimant's last-known addresses of record, a telephone hearing was held on September 1, 2009. The claimant participated in the hearing. Based on the evidence, the arguments of the claimant, and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law, and decision.

ISSUE:

Has the claimant been overpaid \$9,666.08 in benefits he received from February 1 through July 18, 2009?

FINDINGS OF FACT:

The claimant established a claim for benefits in Iowa during the week of February 1, 2009. The claimant filed claims for the weeks ending February 7 through July 18, 2009. Iowa paid the claimant his maximum weekly benefits of \$389.00 for each of these weeks, except for the week ending June 27. For this week, the claimant received \$194.08 in benefits because he exhausted his regular unemployment insurance benefits from Iowa. The claimant received an additional \$25.00 a week in benefits from the government's economic stimulus program for the weeks ending February 28 through July 18, 2009.

The claimant appealed a representative's July 22, 2009 decision that held he was not eligible to receive benefits from the state of Iowa. Based on the decision for appeal 09A-UI-11785-DWT, the claimant is not legally entitled to receive benefits from Iowa as of February 1, 2009. This is because after the wages that had been initially reported to Iowa were transferred to Missouri; the claimant was not monetarily eligible to receive benefits from Iowa.

The claimant has subsequently filed a claim for unemployment from the state of Missouri with an effective date of February 1, 2009.

REASONING AND CONCLUSIONS OF LAW:

If an individual receives benefits he is not legally entitled to receive, the Department shall recover the benefits even if the individual acted in good faith and is not at fault in receiving the overpayment. Iowa Code § 96.3-7. Based on the decision for appeal 09A-UI-11785-DWT, the claimant is not legally entitled to receive unemployment benefits from the state of Iowa as of February 1, 2009. Even though he has been found eligible to receive benefits from Missouri, since Iowa paid him benefits, he has been overpaid a total of \$9,666.08 in benefits he received from Iowa for the weeks ending February 7 through July 18, 2009. The claimant is NOT at fault in receiving the overpayment.

Since the claimant has been found eligible to receive benefits from Missouri, benefits he receives from Missouri for the weeks February 1 through July 18, 2009, should be used to offset or payback the benefits he received from Iowa for these same weeks. If the benefit the claimant receives from Missouri does not completely offset the benefits he received from Iowa, the claimant is responsible for paying back the balance to Iowa.

DECISION:

The representative's August 12, 2009 decision (reference 03) is affirmed. The claimant has been overpaid a total of \$9,666.08 in benefits he received from Iowa for the weeks ending February 7 through July 18, 2009. The claimant is NOT at fault in receiving the overpayment. Since the claimant is eligible to receive benefits from Missouri and his claim has been backdated to February 1, 2009, the benefits the claimant receives from Missouri for these same weeks should be used to offset or reduce the overpayment established in Iowa.
