## STATEMENT OF THE CASE:

Walter L. Campbell, the claimant/appellant,¹ appealed the Iowa Workforce Development (IWD) December 18, 2023, (reference 02) unemployment insurance (UI) decision. IWD denied Mr. Campbell REGULAR (state) UI benefits because IWD concluded he voluntarily quit on November 23, 2023 and he did not give IWD proof that he had good cause to quit. On March 29, 2024, the Iowa Department of Inspections, Appeals, and Licensing (DIAL), UI Appeals Bureau mailed a notice of hearing to Mr. Campbell and the employer for a telephone hearing scheduled for April 19, 2024.

The administrative law judge held a telephone hearing on April 19, 2024. Mr. Campbell participated in the hearing personally. The employer did not participate in the hearing. The administrative law judge took official notice of the administrative record.

The administrative law judge concludes Mr. Campbell is eligible for UI benefits, as long as no other decision denies him benefits, because he appealed on time, and his separation from employment with Peopleready, Inc. was with good cause attributable to the employer.

## **ISSUES:**

Did Mr. Campbell appeal on time?

Did Mr. Campbell voluntarily guit without good cause attributable to the employer?

## FINDINGS OF FACT:

Having reviewed the evidence in the record, the administrative law judge finds: IWD mailed the December 18, 2023 (reference 02) UI decision to Mr. Campbell at his correct address. The UI decision states that it becomes final unless an appeal is postmarked or received by the IWD Appeals Section by Thursday, December 28, 2023.

Mr. Campbell did not receive the decision in the mail. Mr. Campbell called IWD in March 2024 to see if he could get UI benefits. The IWD representative told Mr. Campbell about the reference 02 decision and told him about his appeal rights.

Mr. Campbell appealed via email the next day, March 28, 2024. The DIAL, UI Appeals Bureau received Mr. Campbell's appeal the day he appealed.

The administrative law judge further finds: Mr. Campbell began working for the employer in October 2023. He worked as a full-time cleaner assigned to work at the Tyson Event Center. He worked on October 21 and 22. The employer directed Mr. Campbell to look at the employer's application (app) to find new assignments. Mr. Campbell looked at the app for several days after October 22. The employer did not have work available in his area. Mr. Campbell then began looking for other work.

## **REASONING AND CONCLUSIONS OF LAW:**

For the reasons that follow, the administrative law judge concludes: 1) Mr. Campbell appealed the December 18, 2023 (reference 02) UI decision on time, and 2) Mr. Campbell's separation from employment with the employer was with good cause attributable to the employer.

## Mr. Campell Appealed on Time

lowa Code § 96.6(2) provides, in relevant part: "[u]nless the claimant or other interested party, after notification or within ten calendar days after notification was mailed to the claimant's last known address, files an appeal from the decision, the decision is final and benefits shall be paid or denied in accordance with the decision."

Iowa Admin. Code r. 871-24.35(1) provides:

- 2. Except as otherwise provided by statute or by division rule, any payment, appeal, application, request, notice, objection, petition, report or other information or document submitted to the division shall be considered received by and filed with the division:
  - (2) If transmitted via the United States Postal Service on the date it is mailed as shown by the postmark, or in the absence of a postmark the postage meter mark of the envelope in which it is received; or if not postmarked or postage meter marked or if the mark is illegible, on the date entered on the document as the date of completion.
- (b) If transmitted via the State Identification Date Exchange System (SIDES), maintained by the United States Department of Labor, on the date it was submitted to SIDES.
- (c) If transmitted by any means other than [United States Postal Service or the State Identification Data Exchange System (SIDES)], on the date it is received by the division.

Iowa Admin. Code r. 871-24.35(2) provides:

2. The submission of any payment, appeal, application, request, notice, objection, petition, report or other information or document not within the specified statutory or regulatory period shall be considered timely if it is established to the satisfaction of the

division that the delay in submission was due to division error or misinformation or to delay or other action of the United States postal service.

The Iowa Supreme Court has declared that there is a mandatory duty to file appeals from representatives' decisions within the time allotted by statute, and that the administrative law judge has no authority to change the decision of a representative if a timely appeal is not filed.<sup>2</sup> Compliance with appeal notice provisions is jurisdictional unless the facts of a case show that the notice was invalid.<sup>3</sup>

Mr. Campbell did not receive the December 18, 2023 (reference 02) UI decision before the appeal deadline and, therefore, could not have appealed by the deadline. The notice provision of the decision was invalid. Mr. Campell appealed the day after he learned about the decision. Mr. Campbell appealed on time.

Mr. Campbell's Separation from Employment on October 22, 2023 Was With Good Cause
Attributable to the Employer, So He Is Eligible For UI Benefits

Iowa Code section 96.5(1)j provides:

An individual shall be disqualified for benefits:

- 1. Voluntary quitting. If the individual has left work voluntarily without good cause attributable to the individual's employer, if so found by the department.
- j. (1) The individual is a temporary employee of a temporary employment firm who notifies the temporary employment firm of completion of an employment assignment and who seeks reassignment. Failure of the individual to notify the temporary employment firm of completion of an employment assignment within three working days of the completion of each employment assignment under a contract of hire shall be deemed a voluntary quit unless the individual was not advised in writing of the duty to notify the temporary employment firm upon completion of an employment assignment or the individual had good cause for not contacting the temporary employment firm within three working days and notified the firm at the first reasonable opportunity thereafter.
- (2) To show that the employee was advised in writing of the notification requirement of this paragraph, the temporary employment firm shall advise the temporary employee by requiring the temporary employee, at the time of employment with the temporary employment firm, to read and sign a document that provides a clear and concise explanation of the notification requirement and the consequences of a failure to notify. The document shall be separate from any contract of employment and a copy of the signed document shall be provided to the temporary employee.
- (3) For the purposes of this lettered paragraph:
- (a) "Temporary employee" means an individual who is employed by a temporary employment firm to provide services to clients to supplement their work force

during absences, seasonal workloads, temporary skill or labor market shortages, and for special assignments and projects.

(b) "Temporary employment firm" means a person engaged in the business of employing temporary employees.

The purpose of the statute is to provide notice to the temporary agency employer that the claimant is available for work at the conclusion of each temporary assignment so they may be reassigned and continue working. The language of the statute allows benefits for a claimant who notifies the temporary employment firm of completion of an assignment and who seeks reassignment.

Iowa Admin. Code r. 871-24.26(15) provides:

Voluntary quit with good cause attributable to the employer and separations not considered to be voluntary quits. The following are reasons for a claimant leaving employment with good cause attributable to the employer:

Employee of temporary employment firm.

- a. The individual is a temporary employee of a temporary employment firm who notifies the temporary employment firm within three days of completion of an employment assignment and seeks reassignment under the contract of hire. The employee must be advised by the employer of the notification requirement in writing and receive a copy.
- b. The individual shall be eligible for benefits under this subrule if the individual had good cause for not contacting the employer within three days and did notify the employer at the first reasonable opportunity.
- c. Good cause is a substantial and justifiable reason, excuse or cause such that a reasonable and prudent person, who desired to remain in the ranks of the employed, would find to be adequate justification for not notifying the employer. Good cause would include the employer's going out of business; blinding snow storm; telephone lines down; employer closed for vacation; hospitalization of the claimant; and other substantial reasons.
- d. Notification may be accomplished by going to the employer's place of business, telephoning the employer, faxing the employer, or any other currently accepted means of communications. Working days means the normal days in which the employer is open for business.

In this case, Mr. Campbell asked for a new assignment by looking at the employer's app, as he was directed by the employer. Mr. Campbell did this for several days after his assignment ended. Mr. Campbell did what he was supposed to do – he asked for a new assignment within 3 days after his assignment ended. Mr. Campbell is eligible for UI benefits based on how his job ended with this employer.

## **DECISION:**

Mr. Campbell appealed the December 18, 2023 (reference 02) UI decision on time. The December 18, 2023 (reference 02) UI decision is REVERSED. Mr. Campbell's separation from employment with the employer on October 22, 2023 with good cause attributable to the employer. Mr. Campbell is eligible for UI benefits, as long as no other decision denies him UI benefits.

**APPEAL RIGHTS.** If you disagree with this decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

## AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. **Note to Parties:** YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

**Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.

- 3) Que se interponga recurso de apelación contra tal decisión y se firme dicho recurso.
- 4) Los fundamentos en que se funda dicho recurso.

Una decisión de la Junta de Apelaciones de Empleo es una acción final de la agencia. Si una de las partes no está de acuerdo con la decisión de la Junta de Apelación de Empleo, puede presentar una petición de revisión judicial en el tribunal de distrito.

2. Si nadie presenta una apelación de la decisión del juez ante la Junta de Apelaciones Laborales dentro de los quince (15) días, la decisión se convierte en acción final de la agencia y usted tiene la opción de presentar una petición de revisión judicial en el Tribunal de Distrito dentro de los treinta (30) días después de que la decisión adquiera firmeza.
