## STATEMENT OF THE CASE

On December 12, 2011, Iowa Workforce Development ("IWD") issued a decision reference 02 determining that the appellant was ineligible to receive unemployment insurance benefits as of November 27, 2011. Mr. Hampton filed the present appeal of that decision in a timely manner.

IWD transferred the case to the Iowa Department of Inspections and Appeals, Division of Administrative Hearings, on January 17, 2012 to schedule a contested case hearing. Notice of hearing issued on January 18, 2012, and hearing in this matter was set for February 27, 2011, at 8:00 a.m.

On February 27, 2012, the appellant appeared for the hearing and Kimberly Wilhelm appeared for IWD. Ms. Wilhelm stated that IWD had reversed the decision under appeal upon reconsideration of available information. A new decision will issue establishing the appellant's eligibility for benefits as of November 27, 2011. The appellant, Thompson G. Hampton stated that he no longer wished to pursue the appeal. IWD's rules allow an appellant to withdraw an appeal at any time prior to the issuance of a decision, with the approval of the administrative law judge. 871 IAC 26.8(1). The request to withdraw this appeal is granted.

## **DECISION**

Thompson G. Hampton's request to withdraw this appeal is granted. The matter is deemed WITHDRAWN, and the February 27, 2012, hearing is vacated.
