STATEMENT OF THE CASE:

The claimant filed an appeal from the September 13, 2022 (reference 03), unemployment insurance decision that denied benefits based upon her not being able to and available for work effective August 21, 2022. The parties were properly notified about the hearing. A telephone hearing was held on October 13, 2022. Claimant, Hanna Lantau, participated and testified. Employer, Express Services Inc, did not participate. No exhibits were offered or admitted.

ISSUE:

Was the claimant able to and available for work effective August 21, 2022?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Claimant was employed beginning April 4, 2022 as a full-time receiving clerk. Her immediate supervisor was Kelly Franklin. The claimant last worked for this employer August 24, 2022. The claimant was discharged from employment. The claimant's mother was terminally ill. The claimant was told it was best if she stayed home to take care of her mother and she could return when she was able. The leave of absence was a 30 day maximum, so the employer said it was best to do it that way. The employer had full-time work available, however, the claimant could only work part-time during the time she was caring for her mother. No part-time work was available. The claimant's mother passed on September 25, 2022. The claimant was ready, willing and able to return to work on September 26, 2022.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes the claimant is not able to and available for work effective August 21, 2022.

lowa Code § 96.4(3) provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work. This subsection is waived if the individual is deemed partially unemployed, while employed at the individual's regular job, as defined in § 96.19, subsection 38, paragraph "b", subparagraph 1, or temporarily unemployed as defined in § 96.19, subsection 38, paragraph "c". The work search requirements of this subsection and the disqualification requirement for failure to apply for, or to accept suitable work of § 96.5, subsection 3 are waived if the individual is not disqualified for benefits under § 96.5, subsection 1, paragraph "h".

Iowa Admin. Code r. 871-24.22(1)a provides:

Benefits eligibility conditions. For an individual to be eligible to receive benefits the department must find that the individual is able to work, available for work, and earnestly and actively seeking work. The individual bears the burden of establishing that the individual is able to work, available for work, and earnestly and actively seeking work.

(1) *Able to work.* An individual must be physically and mentally able to work in some gainful employment, not necessarily in the individual's customary occupation, but which is engaged in by others as a means of livelihood.

a. Illness, injury or pregnancy. Each case is decided upon an individual basis, recognizing that various work opportunities present different physical requirements. A statement from a medical practitioner is considered prima facie evidence of the physical ability of the individual to perform the work required. A pregnant individual must meet the same criteria for determining ableness as do all other individuals.

To be able to work, "[a]n individual must be physically and mentally able to work in some gainful employment, not necessarily in the individual's customary occupation, but which is engaged in by others as a means of livelihood." *Sierra v. Employment Appeal Board*, 508 N.W.2d 719, 721 (lowa 1993); *Geiken v. Lutheran Home for the Aged*, 468 N.W.2d 223 (lowa 1991); lowa Admin. Code r. 871-24.22(1). "An evaluation of an individual's ability to work for the purposes of determining that individual's eligibility for unemployment benefits must necessarily take into consideration the economic and legal forces at work in the general labor market in which the individual resides." *Sierra* at 723. The court in *Gilmore v. Empl. Appeal Bd.*, 695 N.W.2d 44 (lowa Ct. App. 2004) noted that "[i]nsofar as the Employment Security Law is not designed to provide health and disability insurance, only those employees who experience illness-induced separations that can fairly be attributed to the employer are properly eligible for unemployment benefits." *White v. Emp't Appeal Bd.*, 487 N.W.2d 342, 345 (lowa 1992) (citing *Butts v. Iowa Dep't of Job Serv.*, 328 N.W.2d 515, 517 (lowa 1983)).

The claimant was not working after August 24, 2022 because she wanted to care for her terminally ill mother. The claimant was not ill or injured, however, she was not willing to work her regular, full-time job. Since claimant is unavailable to perform her work duties because she wanted to stay home to care for her terminally ill mother, she has not established her ability to or availability for work. Benefits are denied.

DECISION:

The September 13, 2022 (reference 03) unemployment insurance decision is affirmed. The claimant is not able to work effective August 24, 2022. Benefits are withheld until such time as the claimant demonstrates she is ready, willing and able to perform work.

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. If you wish to be represented by a law yer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
