Section 96.4-4 - \$250.00 Earnings Requirement

STATEMENT OF THE CASE:

David R. Copell filed a timely appeal from an unemployment insurance decision dated March 17, 2004 reference 01 which denied benefits effective March 7, 2004 upon a finding that he had not earned and been paid insured wages of at least \$250.00 since March 9, 2003, the beginning of his previous benefit year. After due notice was issue, a telephone hearing was held April 12, 2004 with Mr. Copell participating. Exhibit 1 was admitted into evidence.

FINDINGS OF FACT:

Having heard the testimony of the witness and having examined all the evidence in the record, the administrative law judge finds: During the week ending April 8, 2004 David R. Copell

earned gross wages of \$280.00 in covered employment with Ehlers Bookkeeping and Tax Service. These wages will be reported in the employer's quarterly report for the second quarter of 2004. Mr. Copell was paid the wages on April 9, 2004.

REASONING AND CONCLUSIONS OF LAW:

The question is whether Mr. Copell meets the eligibility requirement established by Iowa Code Section 96.4-4 of earning and being paid insured wages of at least \$250.00 since the beginning of his most recent benefit year. The evidence in the record establishes that Mr. Copell earned and was paid the required amount during the week ending April 10, 2004. Therefore, benefits are allowed as of Sunday, April 11, 2004.

DECISION:

The unemployment insurance decision dated March 17, 2004 reference 01 is modified. The claimant is eligible to receive unemployment insurance benefits effective April 11, 2004, provided he is otherwise eligible.
