STATEMENT OF THE CASE:

On September 7, 2023, the employer filed an appeal from the August 9, 2023, (reference 05) statement of charges for the second quarter of 2023. The parties were properly notified about the hearing. A telephone hearing was held on September 25, 2023. Claimant, Jared J. Van Lengen, participated, with witness Charlotte Van Lengen. Employer, Casey's Marketing Company, participated through Operations Manager Jennifer Juarez. No exhibits were offered or admitted. The administrative law judge took official notice of the administrative record, including an unemployment insurance decision issued May 9, 2023, (reference 01), and the appeal decision in 23A-UI-05144-LJ-T.

ISSUES:

Was the employer's protest timely?
Was the employer's appeal from the statement of charges timely?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Claimant filed a claim for unemployment insurance benefits with an effective date of April 16, 2023. Iowa Workforce Development (IWD) sent a notice of claim to the employer through the online SIDES system on April 19, 2023. The employer submitted its response to that notice of claim through the same system on April 27, 2023.

Next, IWD sent an unemployment insurance decision regarding the separation from employment. That decision, dated May 9, 2023, (reference 01) denied benefits. Claimant appealed the decision and, in the decision for appeal number 23A-UI-05144-LJ-T, the administrative law judge reversed and allowed claimant benefits. The employer did not receive the unemployment insurance decision or the appeal decision. It did receive the notice of hearing for appeal number 23A-UI-05144-LJ-T.

The employer received the statement of charges dated August 9, 2023, (reference 05) for the second quarter of 2023. The statement included a charge for benefits paid to the claimant. The employer filed its appeal of the statement of charges on September 7, 2023.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes the employer has not appropriately filed an appeal of the statement of charges.

Iowa Code section 96.6(2) provides, in pertinent part:

2. Initial determination. A representative designated by the director shall promptly notify all interested parties to the claim of its filing, and the parties have ten days from the date of mailing the notice of the filing of the claim by ordinary mail to the last known address to protest payment of benefits to the claimant.

Iowa Code section 96.7(2)a(6) provides:

2. Contribution rates based on benefit experience.

a. (6) Within forty days after the close of each calendar quarter, the department shall notify each employer of the amount of benefits charged to the employer's account during that quarter. The notification shall show the name of each individual to whom benefits were paid, the individual's social security number, and the amount of benefits paid to the individual. An employer which has not been notified as provided in section 96.6, subsection 2, of the allowance of benefits to an individual, **may within thirty days after the date of mailing of the notification appeal to the department for a hearing to determine the eligibility of the individual to receive benefits.** The appeal shall be referred to an administrative law judge for hearing and the employer and the individual shall receive notice of the time and place of the hearing. [Emphasis added.]

Iowa Admin. Code r. 871—26.4 provides, in relevant part:

2. An appeal from an initial decision concerning the allowance or denial of benefits shall be filed, by mail, facsimile, or e-mail, online, or in person, not later than ten calendar days, as determined by the postmark or the date stamp after the decision was mailed to the party at its last-known address and shall state the following:

- a. The name, address and social security number of the claimant;
- b. A reference to the decision from which appeal is taken; and,
- c. The grounds upon which the appeal is based.

3. Notwithstanding the provisions of subrule 26.4(2), a contributory employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 30 days from the mailing date of the quarterly statement of benefit charges.

4. Also notwithstanding the provisions of subrule 26.4(2), a reimbursable employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 15 days of the mailing date of the quarterly billing of benefit charges.

(Emphasis added.) As pointed out in emphasis above, an employer may only appeal a claimant's eligibility for benefits through the quarterly statement of charges when it has not previously received notice of the filing of a valid claim for benefits. In this case, the employer received notices of claimant's claim for benefits prior to the statement of charges mailed August 9, 2023. Even if the employer did not receive the administrative law judge's decision following the appeal hearing, the appropriate remedy is not an appeal of the statement of charges. The record developed in this hearing illustrates that the employer has received notice of the claimant's filing of a valid claim for benefits, and it may not appeal the quarterly statement of charges.

DECISION:

The August 9, 2023, (reference 05) statement of charges for the second quarter of 2023 is AFFIRMED.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at <https://www.legis.iowa.gov/docs/code/17A.19.pdf> or by contacting the District Court Clerk of Court <https://www.iowacourts.gov/iowa-courts/court-directory/>.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.

- 4) Los fundamentos en que se funda dicho recurso.

Una decisión de la Junta de Apelaciones de Empleo es una acción final de la agencia. Si una de las partes no está de acuerdo con la decisión de la Junta de Apelación de Empleo, puede presentar una petición de revisión judicial en el tribunal de distrito.

2.
